IN ADDITION, A GENERAL LIABILITY INSURANCE POLICY OF \$1,000,000 (UNLESS OTHERWISE NOTED) IS REQUIRED. *BIG BEND NATIONAL PARK, NATIONAL PARK SERVICE* WILL BE NAMED AS THE INSURED AND THE *UNITED STATES GOVERNMENT* AS THE ADDITIONAL INSURED ON THE INSURANCE CERTIFICATE.

FINALLY, A PERFORMANCE BOND IN THE FORM OF A CASHIERS CHECK OR CERTIFIED CHECK MAY BE REQUIRED TO COVER RESOURCE DAMAGE RESULTING FROM THE ACTIVITIES OF THE PERMITTEE.
