In accordance with 36 Code of Federal Regulations 2.62 (b), the scattering of human ashes from cremation is prohibited, except pursuant to the terms and conditions of a permit, or in designated areas according to conditions which may be established by the superintendent. The following are the terms and conditions established by the Superintendent, Cabrillo National Monument.

***Memorial Service &  
Scattering of Ashes from Cremation  
Guidelines***

- Contact the park to make sure date and time is available for the service.
- Scattering of human ashes from cremation is permitted only adjacent to the south of Sea Cove Parking Area. The memorials service is permitted at the viewing area west of the Sea Cove Parking Area.
- Services of over 50 people are not permitted. This area does not accommodate more than this number.
- Set ups such as chairs, carpets, organs, podiums, or related items are not allowed. Often there may be an elderly person who must sit down during the service; someone may bring a chair for that person and carry it out when leaving. Chairs may not be set up in advance of the service.
- Services may not start later than 3:30 PM.
- Receptions are not permitted in the park.
- There is no alternate location for the service should it rain.
- The park entrance fee of \$5.00 per car will be charged.
- Non-amplified music from flutes, harps, guitars, etc. is permitted. Amplified music or public address systems are not permitted.
- Cars must park at Sea Cove Parking Area. Carpooling is highly encouraged.
- Flowers are permitted as long as they arrive and depart with the permittee. No mementos of any kind may be left in the park.
