

# Casa Grande Ruins National Monument Outdoor Kitchen and Ramada Facility Use Permits



**Reservations for Facility Use Permits for the Outdoor Kitchen and Ramada are now accepted for use between 9:00 a.m. and 5:00 p.m.**

**A Special Park Use Permit is required for use before and after public hours.**

**The Outdoor Kitchen and Ramada includes a covered kitchen and picnic area with florescent lighting and a fireplace. Ten to twelve picnic tables are arranged under the ramada. The U-shaped kitchen area has a covered propane grill, two open gas burners, two stainless steel sinks with hot and cold water, and serving counters.**



**Electricity, water, and propane costs are included in user fees. Firewood is not provided. Restrooms are available outside the visitor center, across the parking lot from the picnic area. Cleaning supplies, towels and trash bags must be provided by the permit holder. Trashcans are distributed around the picnic tables. Permit holders are required to empty the trashcans and bag garbage for transport to dumpsters at the end of the event.**

**Automobile parking** is available adjacent to the outdoor kitchen. The parking lot accommodates 52 vehicles, including 5 handicap parking spaces and 10 spaces for recreational vehicles. No parking is allowed outside of designated parking area or along roadways.

**Hours for Use:** The Outdoor Kitchen and Ramada is available for reservation between regular Monument hours, 9:00 a.m. to 5:00 p.m. under the following fee structure. The facility may also be available before and after regular hours, by obtaining a Special Park Use Permit. Special Use Permit fees are also listed below.

**Day Use Fees:**

- One-day use of outdoor kitchen and picnic ramada—9:00 a.m. to 5:00 p.m. \$120
- Two-hour minimum day use—from 9:00 a.m. to 5:00 p.m. \$ 50/hr
- Hourly rate for day use after two hour minimum \$ 10/hr
- Hourly early morning and evening rate—before 9:00 a.m. and after 5:00 p.m. \$ 75/hr
- NPS assistance for set up or clean up (per person) \$ 50/hr
- Refundable cleaning deposit \$100

**Special Park Use Fees (Early Morning and Evening Use):**

- Application fee (nonrefundable) \$ 50
- Administration fee \$ 50
- Two-hour minimum facility use \$ 50/hr
- Hourly facility use rate after two hour minimum \$ 10/hr
- NPS assistance for set up or clean up (per person) \$ 50/hr
- NPS site staffing (per person)—site access and security \$ 75/hr
- Refundable cleaning deposit \$100

If additional NPS staff is required for public or resource protection, users will be billed an additional \$85/hour/person. Users will also be held liable for and billed for any damages to facilities or other park resources.

**Limitations and Requirements of Use:**

- Alcohol is permitted during functions at the Outdoor Kitchen and Ramada, but kegs are limited to group reservations only. All alcoholic beverages must remain within the picnic area.
- The facilities and grounds must be “policed” with all litter picked up and removed at the end of the event.
- The kitchen must be wiped down and swept, and the grill, sink, and fireplace left clean.
- Users must provide their own firewood if they wish to use the fireplace, and are required to thoroughly extinguish fire and clean fireplace before vacating the facility.
- National park representatives will open and secure the park gate and restrooms. Contact the ranger on duty at the visitor center between the hours of 9:00 a.m. and 5:00 p.m. to make arrangements.
- Facility use permit allows access to picnic area, parking lot, and visitor center restroom and porch area only. Trespass into closed areas is subject to fines.

Additional requirements may be placed on event organizers dependent on function planned.
