COMMERCIAL FILMING RATE INFORMATION

FILMING RATE SCHEDULE

APPLICATION FEE (**Non Refundable**): \$50.00

ADMINISTRATIVE FEE (**Non Refundable**): \$50.00 Per Hour (MINIMUM 2 hours)

NATIONAL PARK SERVICE SUPERVISION/MONITORING: \$50.00 per hour/per ranger, \$75.00 per hour/per ranger for use of monument outside normal operational hours (e.g.: access to monument for sunrise/set)

SPOT MONITORING of crew: \$150.00 per day minimum charge.

CONTINUOUS MONITORING of crew: \$150.00 per day minimum charge or \$50.00 per hour/per ranger.

Monument Equipment charge: \$120.00

CANCELLATION FEE (**Non Refundable**) per scheduled ranger for schedule changes without **36 hour** advance notification \$100.00

LOCATION FEE (**No Waivers Allowed**): \$0 per day 1-2 people, camera and tripod only

MAKE ALL CERTIFIED CHECKS PAYABLE TO THE NATIONAL PARK SERVICE.

APPLICATION

Commercial filming application and fees will be accepted no later than **seven business days** prior to the requested date(s).

INSURANCE REQUIREMENTS

General liability insurance requires that the **US GOVERNMENT: NATIONAL PARK SERVICE** be listed as additional insured in the amounts of:

- 1) Still Photography: \$300,000.00 bodily injury plus \$50,000.00 property damage per occurrence
- 2) Motion/Electronic Media: \$1,000,000.00
- 3) Special activities with high damage/injury risks: \$3,000,000.00

ORIGINAL CERTIFICATE OF INSURANCE MUST BE RECEIVED AT CASA GRANDE RUINS NATIONAL MONUMENT BEFORE PERMIT WILL BE ISSUED.

BOND REQUIREMENTS

Permittee is required to post a bond to assure the area used is left in its original condition. A cash deposit or a certified bank check is required. **Bond will be calculated by cost recovery and will be determined by the size, number of hours and days, and overall complexity of the operation.** Estimated **MINIMUM** bond amounts for size of operation are as follows:

- 1) Still Photography: no stock; no models; no props or sets: \$500.00
- 2) Still/Motion Photography: two to five people; no stock: \$1,000.00
- 3) Still/Motion Photography: six to twenty-four people and/or up to five days scheduled filming; complex sets; construction of sets at location: \$2,000.00. PLUS Stock use: \$100.00 per animal/per day.
- 4) Still/Motion Photography: twenty-five or more people and/or five or more days scheduled filming; complex sets; construction of sets at location: Bond will be calculated by cost recovery and/or supervision. PLUS Stock use: \$100.00 per animal/per day.
