# **HISTORY**

Cane River National Heritage Area (CRNHA) was established in 1994 by Public Law 103-449; 16 U.S.C. 410 and includes historical, agricultural, architectural, cultural and natural features in northwestern Louisiana. The heritage area includes Cane River Creole National Historical Park, seven National Historic Landmarks, three State Historic Sites, and other historic plantations, homes, and churches.

Included in CRNHA is the Lambre Bros. Gin, across from the north end of Oakland Plantation along Louisiana Highway 494, where the Lambre Family operated a cotton gin and store, which previously served as a school. Jules Murray Lambre (1912-1975) and Alton James Lambre (born 1940) operated the gin beginning as early as 1951, ginning locally grown cotton for planters from the 1950s to the 1970s. The gin building and property was later acquired by Willie Rush (born 1930) who operated "Bermuda Forge and Metalworks," a blacksmith shop, until approximately 1990 on the premises.

Approximately one half mile northwest of the Lambre Bros. Gin, the Ducournau Family historically owned land known as "Hope Plantation" or "The Old Plauche Place." J.A. Ducournau, Sr. (1812-1905) was born in France, and later immigrated to Louisiana. He married Appoline Castenado of New Orleans in 1849, and the couple had two children: Estelle (1850-1926), who married A.J. Plauche, and J.A. Ducournau, Jr. (1851-1906). J.A. Ducournau, Sr. and Jr. owned and operated a general merchandise store on Front Street in Natchitoches, Louisiana, and had land holdings along Cane River. John Adolph Ducournau (1893-1979), a descendant of J.A. Ducournau, Sr., married Josephine "Jo" Bryan (1899-1996) on March 1, 1931 in Natchitoches, and owned and operated Hope Plantation during the mid-twentieth century. During their marriage, Josephine lived at least part-time in Louisiana, while John lived in and San Francisco, California, where he served as a Vice President of Wells Fargo Bank until his retirement in 1979.

Records span from 1908 to 1971.

Records were created by members of the Ducournau and Lambre families of Natchitoches Parish and primarily reflect the personal lives of John Adolph Ducournau and Josephine Bryan Ducournau, and the business operations of the Lambre Brothers Gin and Store.

Correspondence, booklets, pamphlets, catalogs, postcards, invoices, newspaper clippings, photographs, photographic

negatives, and ledgers.

ORGANIZATION Organized into two subgroups: Subgroup 1: Willie Rush Collection

of Ducornau and Lambre Family Papers; Subgroup 2: The Lambre Brothers Gin and Store Collection. Additional Subgroups can be

added for future accessions.

# SERIES DESCRIPTIONS

I. SUBGROUP 1: WILLIE RUSH COLLECTION OF DUCOURNAU AND LAMBRE FAMILY PAPERS, 1908-1965, UNDATED

Organized into five series: Series I: Correspondence; Series II: Ephemera; Series III: Invoices; Series IV: Newspaper Clippings; Series V: Photographic Materials.

A collection of materials attributed to the Ducournau and Lambre families of Natchitoches Parish, Louisiana. Records include some documentation of Cane River life, and also relate to the extensive domestic and international travel of by the Ducournau family.

Correspondence, ephemera, invoices, newspaper clippings and photographic materials.

A. SERIES I: CORRESPONDENCE, 1908-1965, UNDATED

Arranged alphabetically by recipient and thereunder chronologically.

Letters received by various members of the Ducournau and Lambre families, including: G. Brevelle, Josephine Bryan, K.S. "Kippie" Cocran, Mr. and Mrs. John Adolph Ducournau, Rita Lambre, and others. Topics include: courtship, local events and news, family and friends, invitations, thank-you letters, and business matters.

B. SERIES II: EPHEMERA, 1919-1963, UNDATED

Arranged alphabetically by subject.

Musical, religious, school related, travel and other ephemera, most of which was probably collected by the Ducournau family.

Songbooks, catalogs, pamphlets, booklets, poetry, notebooks, postcards, and a certificate to John A. Ducournau for his military service.

C. SERIES III: INVOICES, 1925, UNDATED

Arranged chronologically.

Invoices from Venice and Florence, Italy, and various envelopes from American companies.

D. SERIES IV: NEWSPAPER CLIPPINGS, 1932-1933

Arranged chronologically.

Newspaper clippings from "Farm and Ranch," and other unidentified newspapers.

E. SERIES V: PHOTOGRAPHIC MATERIALS, 1937, UNDATED

Arranged by format, and thereunder by size.

Photographic materials including negatives and photographic prints, created by the Ducournau family. No persons are identified, and only a small group of prints are dated. Subjects include portraits, home scenes, general family pictures, Cane River and Natchitoches Parish life, the Kaffie family of Natchitoches Parish, and foreign travels.

II. SUBGROUP 2: THE LAMBRE BROTHERS GIN AND STORE COLLECTION, 1957-1971

Organized into two series: Series I: Ledgers; [Series II: Materials to be Added from Future Accessions].

Document the operation of the Lambre Brothers Gin and Store. Includes ledgers used for wages, tracking of livestock and crops, expenses, ginning of cotton, and other miscellaneous transactions. Entries generally pertain to the title given on the ledger, though some were used for multiple purposes.
