# Commercial Use Authorization—Appendix B Guided Backcountry Stock/Packing Trips

## I. GENERAL INFORMATION

(A) The following provisions apply to CUAs for stock/packing trips (both single day and overnight trips):

- (1) 15 people and 15 animals per party (maximum), including guides. Groups larger than 15 people and 15 animals must split up and camp at least one mile apart.
- (2) The park permits horses, mules, burros, oxen, llamas and camels for use as pack animals on backcountry roads, in wilderness areas and on designated horse trails in the Furnace Creek area. Pack stock are prohibited from using the following trails and areas: Badwater Trail, Salt Creek Trail, Mosaic Canyon Trail, Ubehebe Crater Trail, Eureka Sand Dunes area, Darwin Falls Trail, Telescope Peak Trail, Trail to Scotty's Grave, Golden Canyon/Gower Gulch Loop Trail, all campgrounds and picnic areas, all lawn areas, and all areas closed to the public (see section (B) below).
- (3) All food for pack stock must be brought in; ranging/grazing is not permitted.
- (4) The use of weed-free feed is required.
- (5) All manure should be removed, especially at roadside campsites. Where removal is not practical, manure must be raked out and spread over a large area.
- (6) Unless an area is closed to backcountry camping (see section (B) below), backcountry camping with stock is permitted 2 miles from the nearest paved road, day use road, or developed area. Roadside camping in these backcountry locations is permitted in previously disturbed areas.
- (7) All backcountry stock camps must be 200 yards from the nearest water source.
- (8) Leave No Trace principles and ethics are in effect for backcountry campers. Group leaders must be trained in Leave No Trace camping and stock-packing principles.
- (9) Group leaders and guides must be currently certified at the Wilderness First Responder or First Responder level for emergency medical care. Group leaders will provide initial response to emergency medical incidents.
- (10) Off-road vehicular travel is prohibited. Keep all vehicles and trailers on established roadways and shoulders. Maximum speed limit for all dirt roads is 25MPH.
- (11) All natural and cultural features are protected by law and must not be disturbed or molested. Non-native or exotic species of plants or animals will not be introduced to the park by any proposed activities.
- (12) Groups will notify the Death Valley National Park permits office of all proposed trips and any proposed changes to trip itineraries. Failure to do so will result in the revocation of a commercial use authorization as well as other associated permits.
- (13) Group leaders and guides are required to ensure that participants pay their park entry fees at the individual rate (currently \$10.00 per person, valid for 7 consecutive days). Holders of a commercial use authorization will be held responsible for assuring that entry fees are paid by all participants.
- (10)CUA does not imply exclusive use of any area in the Park. All campgrounds and other park facilities are available for use on a first-come, first-served basis.

(B) **Closures:** The following areas are closed to backcountry camping.

Dirt Roads and rights-of-way: Titus Canyon Road, West Side Road, Wildrose Road, Aguerberry Point Road, Cottonwood Canyon Road (first 8 miles), Racetrack Road (From Teakettle Junction to Homestead Dry Camp, including the Racetrack playa), and short, maintained roads such as Keane Wonder Mine, Mosaic Canyon, Grotto Canyon, Natural Bridge and Devil’s Golf Course.

**Mining Areas:** Lost Burro Mine, Ubehebe Lead Mine.

**Other Geographic Areas:** Anywhere on the floor of Death Valley from Ashford Mill to 2 miles north of Stovepipe Wells, on the active shifting sand dunes of Eureka Dunes, anywhere in the park below sea level.

**The following areas are closed to all entry, except when accompanied by National Park Service personnel:**

Copper Canyon, Devil’s Hole, Titus Canyon Cave, Lower Vine Ranch, American Borate Company mines near Ryan, Timbisha-Shoshone tribal areas near Texas Springs Campground, Crystal Cave/Leadfield Mine/Lower Leadfield Mines in Leadfield, Skidoo Stamp Mill, any mines covered by safety nets or gates, Eureka Mine in Harrisburg Flats (from October 15 through April 15), and any facilities or buildings used for the storage, treatment, or transmission of electricity, gas, telephone, waste disposal or domestic water.

(C) The area(s) authorized for use under this permit must be left in substantially the same condition as it was prior to the conduct of the activity.

(D) The NPS reserves the right to charge the CUA operator for the cost of any search and rescue efforts or for the evacuation of sick or injured members of the CUA operator’s group.

(E) The CUA operator is responsible for notifying the Park of any accident that results in an injury requiring the care of a physician.

(E) Commercial use authorizations issued by Death Valley National Park are only valid for planned and approved activities within Death Valley National Park and are not transferable to other National Park Service units.

## II. APPLICATION CHECKLIST

The following requirements must be met in order for authorization of the Guided Backcountry Stock/Packing Trip CUA’s to be issued from Death Valley National Park (hereinafter “Park”).

(4)	Applicant must present the Park with a <b><i>Standard Operating Plan</i></b> . All Operating Plans will be reviewed by NPS for approval. The Operations Plan will be reviewed for compatibility with the guidelines for commercial services, interpretation, and resource protection at the Park, CUA's will not be issued and trips must not begin until the Operating Plan has been approved.  The Operating Plan, at a minimum, should include: (a) Explanation of services to be provided. (b) Dates that services will be provided. (c) Average and maximum size of group(s) for each type of activity planned. (d) Qualifications roster of individuals guiding in the Park. (e) Outline of environmental education information that will be provided to your clients. (f) Safety and/or sanitation precautions/procedures that apply to your service. (g) Resource protection measures including Leave No Trace. (h) Explanation of the procedures to be taken in case of accidents or other emergencies.
