## ***HISTORY***

Kalaupapa National Historical Park (Kalaupapa NHP) was established as a National Park on December 22, 1980 (P.L. 96-565). From 1980 to 2012, the Park had five Superintendents who administered operations at Kalaupapa National Historical Park including, Henry Law, Peter Thompson, Dean Alexander, Tom Workman, and Stephen Prokop.

Under the jurisdiction of the National Park Service (NPS), the aforementioned Superintendents functioned as the chief executive officers and principal authorities for the daily management, protection, direction, operation and preservation of Kalaupapa National Historical Park. As Superintendents they were the primary accountable officers who ensured that all operations and developments were in compliance with applicable laws and regulations outlined in NPS policies and the Park's enabling legislation. They supervised matters related to preservation, maintenance, development, law enforcement, compliance, and general operations, and served as the principal NPS representatives responsible for enhancing community relations and collaborating with various local, state, and federal agencies.

## ***SCOPE AND CONTENT***

### COLLECTION 1001: SUPERINTENDENT RECORDS 1940s-2012 (bulk dates: 1980-2012)

*DESCRIPTION* The Kalaupapa National Historical Park Superintendent Records (1980-2012) include official NPS records related to the administrative and operational activities of Kalaupapa National Historical Park. These records date from the 1940s-2012, with a bulk of the records occurring from 1995-2011. Document types include correspondence, memorandums, compliance documentation, historic preservation records, construction records, reports, organizational records, concession records, notes, meeting records, visitation records, planning documents, land records, still images, contracts, agreements, fiscal records, and other materials related to the administration of operations at Kalaupapa National Historical Park.

The strengths of this collection are from 1995-2011, with a high volume of documentation pertaining to utility/building transfers between the NPS and Department of Health; concessions; compliance; the General Management Plan; the Ka`Ohana O Kalaupapa Memorial Project; the United Nations Quest for Dignity Exhibit; and line item construction projects, "Package KALA-211" and the "Kalaupapa Pier." Weaknesses of this collection are in Series I-II with sparse documentation accounting for administrative and operational activities between 1980 and 1988.

In 2005 this collection was appraised, arranged and described by Archivist, Carola DeRooy under acquisition standards adhering to the original retention schedule (NPS- 19, Appendix B). Permanent official records, as well as records deemed of lasting value concerning Park operations were incorporated into the Park's archive.

Subsequent to the initial identification and processing of the Park's resource management records, archival recommendations were neglected and the records were either, moved/re-arranged/dis-associated and/or accreted to

existing collections with little documentation or archival interventions. As a result, the collections grew ad hoc without a guiding archival hierarchy.

In 2018, the collection was re-processed by Museum Curator, Julia Aleszczyk.

## ***SERIES DESCRIPTIONS***

### ***SERIES I. HENRY LAW, 1980-1987 (bulk dates: 1984-1987)***

Henry Law was appointed as the first Superintendent for Kalaupapa National Historical Park in 1984. Prior to the establishment of the Park in 1980, Law worked as a Historic Architect for the Denver Service Center where he completed the initial building inventory for both the Kalaupapa and Kalawao settlements (1977). Shortly thereafter, Law worked with Pacific Islands Support Office Superintendent, Bryan Harry to create the Kalaupapa's first Resource Management Plan. Together, they created a priority list of buildings for emergency stabilization, and secured base funding to initiate operations at Kalaupapa NHP. During Law's tenure as Superintendent, he established multiple agreements with state, local, and federal agencies, as well as developed planning documents to support general operations.

This series is arranged by alpha-numeric code (according to NPS-19, Appendix B), and then alphabetically for uncodified files.

This series contains a [restricted] medical file, the Park's enabling legislation, a National Historic Landmark Certificate, compliance documentation for the installation of wayside exhibits and construction of the a concrete boat landing, and correspondence regarding government housing and the child visitation policy.

Records from Law's tenure as Park Superintendent are sparse, but files relating to his work as the Historical Architect and Superintendent can be found in Collection 1000: KALA NHP Central Files.

### ***SERIES II. PETER THOMPSON, 1989-1997 (bulk dates: 1990-1994)***

Peter Thompson was appointed as the second Superintendent of Kalaupapa National Historical Park in 1989. During his tenure he established agreements with state, local, and federal agencies; fostered relations with 'topside' Molokai organizations including the Molokai Planning Commission and the Meyer Ranch; and served as the primary accountable officer for compliance projects.

This series is arranged by alpha-numeric code (according to NPS-19, Appendix B), and then alphabetically for uncodified files.

This series contains Memorandum of Agreements with NPS and state agencies, a General Management Plan, compliance documentation, construction/development proposals, and photographs.

Records from Thompson's tenure as Park Superintendent are sparse, but files relating to his actions as Superintendent can be found in Collection 1000: KALA NHP Central Files.



**SERIES III. DEAN ALEXANDER, 1930s-2000 (bulk dates: 1995-1999)**

Dean Alexander was appointed as the third Superintendent of Kalaupapa National Historical Park in 1994. During his tenure he focused on enhancing community relations with patients, state, and local governments. He established an agreement with Arizona Memorial Museum Association, and participated in the planning for the United Nations Integration, Dignity and Economic Advancement's (IDEA) Quest for Dignity exhibit. He served as the primary accountable officer for filming permits and compliance projects, and served as the principle authority for concessionaire operations, development proposals, and land management issues.

This series is arranged by alpha-numeric code (according to NPS-19, Appendix B), and then alphabetically for uncodified files.

This series contains correspondence, memoranda, project proposals, filming permits, organizational records, newspaper clippings, draft management plans, Quest for Dignity exhibit documentation, budget allocations, photographs, land closures, notices, leases, and compliance documentation for the rehabilitation of Paschoal Hall, the construction of an ungulate exclosure fence, and the Kalaupapa water supply system.

**SERIES IV. TOM WORKMAN, 1985-2005 (bulk dates: 2001-2004)**

Tom Workman was appointed as the fifth Superintendent of Kalaupapa National Historical Park in 2001. During his tenure he collaborated with state and federal agencies for large-scale construction activities including the installation of telecommunication services to Kalaupapa, and line item construction project Package KALA-211. He funded multiple ancillary projects through the Arizona Museum Memorial Association, and served as the primary accountable officer for compliance projects.

This series is arranged by alpha-numeric code (according to NPS-19, Appendix B), and then alphabetically for uncodified files.

This series contains agreements, correspondence, land management plans, planning for telecommunication services, cultural resource project documents, natural resource project documents, compliance documentation, planning records for KALA-211, photographs of buildings and locations within the Kalaupapa settlement, and Kalaupapa Patient Advisory Council meeting minutes.

**SERIES V. STEPHEN PROKOP, 1984-2012 (*bulk dates: 2002-2012*)**

Stephen Prokop was appointed as the sixth Superintendent for Kalaupapa National Historical Park in 2006. During his tenure he continued to foster partnerships with state, local and federal agencies including Ka`Ohana O Kalaupapa, the Office of Hawaiian Affairs, the Department of Hawaiian Homelands, the Department of Health, and the Patient Advisory Commission. He worked closely with the Department of Health to transfer buildings from State to NPS stewardship, and served as the primary accountable officer for new and on-going compliance projects including Package KALA-211, the Kalaupapa Pier project, and the Ka`Ohana O Kalaupapa memorial monument project. He also participated in the planning process for the Park's General Management Plan (GMP).

This series is arranged by alpha-numeric code (according to NPS-19, Appendix B), and then alphabetically for uncodified files.

This series contains contracts, agreements, correspondence; GMP planning documents; and project records related to line item package KALA-211, the Kalaupapa Pier project, the IDEA Quest for Dignity exhibit, and the Ka`Ohana O Kalaupapa memorial monument.
