PREFACE

The bulk of the *Elizabeth Ellery Dana* (1846-1939) *Personal Papers*, 1829-1940 (bulk dates: 1860-1939), was processed by staff at the Northeast Museum Services Center (NMSC) during 2000-2001. The staff included former Society for Preservation of New England Antiquites (SPNEA)¹ Archivist, Jennifer Lyons, and former SPNEA Catalogers, Jalien Hollister and Lauren Malcolm. This team catalogued 8.6 linear feet (13,760 items) during FY 2000. The collection includes materials collected by Harry Wadsworth Longfellow Dana (1881-1950) about his aunt, Elizabeth Ellery Dana (1846-1939) as well as her personal papers. NMSC staff processed additional material, including accession LONG-132, in FY07.

The catalogers from both phases of the project expressed their gratitude towards staff at the Longfellow House-Washington's Headquarters National Historic Site² for their assistance in carrying out this work, particularly Archives Specialist, Anita Israel, former Curator, Janice Hodson, and Site Manager, Jim Shea. Also, the catalogers from the first phase thanked Michelle Ortwein, former NMSC Curator, and Liz Banks, NMSC Archivist, for their assistance.

This document represents many hours of work recording details about the items herein described. The reader should expect a reasonable degree of human error and consequently rely on personal observation of the items.

INTRODUCTION

The *Elizabeth Ellery Dana Personal Papers 1829-1940 (Bulk Dates: 1860-1939)* is an archival collection that was compiled by Elizabeth Ellery Dana (1846-1939) and Henry Wadsworth Longfellow Dana (1881-1950). It is one of the many rich collections held at the Longfellow House, which has been administered by the National Park Service since 1973. The archives collection, including most of the papers of various Dana family members, was accessioned into the Longfellow House – Washington's Headquarters National Historic Site (LONG) museum collection as part of LONG-1 when the Longfellow House Trust donated the Longfellow house and its contents to the National Park Service in 1973.

PROCESSING HISTORY

INITIAL PROCESSING, 1998-2000

In fiscal years 1998 and 1999/2000, staff at the Longfellow National Historic Site³ submitted requests for Backlog Cataloging Funds to catalog a portion of the *Dana Family Papers*. These funding requests were approved, and the park staff requested that the Northeast Museum Services Center (NMSC) complete the work. After creating an inventory and surveying what was thought to be one collection, NMSC and park staff determined that there were actually three collections: *Personal Papers of Elizabeth Ellery Dana (1846-1939)*, *Richard Henry Dana III (1851-1931) Papers*, and the *Dana Family Papers*. The distinction was made because the first two collections are organic personal paper collections left somewhat intact by their creators. On the other hand, the *Dana Family Papers* consists of papers created and collected by Elizabeth Ellery Dana (1846-1939) [EED] and Henry Wadsworth Longfellow Dana (1881-1950) [HWLD] throughout their research into Dana family history. All these collections were a part of accession LONG-1.

The accession LONG-70 portion of the collection was removed from the site sometime after 1950 and returned in January of 1995. LONG staff inventoried the materials. Before this project, some material was removed from this accession and processed with the *Dana Collected Correspondence*, 1808-1938 (LONG 21808). As with that collection, material from accession LONG-70 was marked as such (on the folder) and sorted into the *Dana Family Papers* (LONG 27037), the *Richard Henry Dana III Papers* (LONG 27883) and the *Elizabeth Ellery Dana* (1846-1939) Personal Papers (LONG 27882).

Lauren Malcolm and Jalien Hollister, cataloguers from Society for the Preservation of New England Antiquities (SPNEA) working under a cooperative agreement with the National Park Service, and Jennifer Lyons, NPS/SPNEA Archivist, processed the bulk of the collections.

The material that was processed was arranged into series and rehoused into acid-free folders and archival boxes. All paper clips, staples, and other metal fasteners were removed. Particularly acidic materials were separated from other materials in a folder with acid-free paper.

Oversize items, too large to be stored in standard legal-sized folders, were removed from their respective collection, foldered, and stored in oversize flat boxes. Separation sheets were created for oversize items to cross-reference to their original locations. Items were flattened before their removal when necessary. In the collection listing the symbol "†" indicates an item was removed because of its size. In previous editions of the finding aid, oversize material was treated as a separate subcollection. In this edition of the finding aid, it is listed under the series with which it is intellectually associated.

The Elizabeth Ellery Dana (1846-1939) Personal Papers was cataloged into the National Park Service's database, Automated National Catalog System Plus.

PHOTOGRAPH PROJECT, 2000

The photographs were catalogued in the FY99, 00 Photos project and stored separately in archival housing.

ACCRETION, 2006-2007

Items identified after the initial survey and processing of the papers were added to the collection in early FY07 with Backlog Cataloguing Funds. This included material from accession LONG-1, including pamphlets and documents removed from books related to EED. In addition, accession LONG-132 was donated in January 2006, including a group of incoming correspondence, some of it from Dana family relatives, and financial records, most dating from 1929 to 1936.

As part of the FY2007 project, newsprint, most of it highly acidic and brittle, was removed from collection folders, photocopied onto acid-free paper, and placed into acid-free rehousing. The symbol "‡" in the collection listing indicates that newsprint was removed from the folder. In the second edition of this finding aid, newsprint material was treated as a separate subcollection. In this edition of the finding aid, it is listed under the series with which it is intellectually associated.

Description: The Elizabeth Ellery Dana (1846-1939) Personal Papers is a

collection of papers amassed by Elizabeth Ellery Dana (1846-1939)

[EED] and Henry Wadsworth Longfellow Dana (1881-1950)

[HWLD]. Miss Dana accumulated her own papers during her lifetime and posthumously they were collected by HWLD. These papers were removed from the Dana Family Papers because of their organic nature.

The bulk of her personal correspondence can be found in *Dana*

Collected Correspondence 1808-1938 (LONG 21808).

The collection is divided into three subcollections: I. HWLD Collected

Materials, II. Personal Papers, and III. Photographic Materials.

The first subcollection, I. HWLD Collection Materials, consists of materials collected by HWLD during the final years of EED's life and after her death including correspondence about EED, her health, obituaries and memorials and correspondence to HWLD responding to

EED's death.

The second subcollection, II. Personal Papers, consists of EED's correspondence, school papers, travel, her lists/notes and notebooks,

financial records, legal records, her estate records (collected

posthumously by HWLD), her writing and research, organizations and

collected materials.

RELATED MATERIALS

More papers of the Dana family are deposited at the Massachusetts Historical Society and at the Schlesinger Library of Harvard University. The Massachusetts Historical Society holds the *Dana Family Papers*, 1654-1933, which primarily includes papers from Francis Dana (1743-1811), Richard Henry Dana, Sr. (1787-1879), Richard Henry Dana, Jr. (1815-1882), and Richard Henry Dana III (1851-1931), although other members of the Dana family are also represented. The Schlesinger Library holds the *Dana Family Papers*, 1822-1956, which primarily includes some papers of Sarah Watson Dana (1814-1907), Ruth Charlotte Dana (1814-1901), Elizabeth Ellery Dana (1846-1939), and Rosamond Dana Wild (1879-1959). The papers of EED in this collection include correspondence, genealogical research materials and many of her diaries.

In addition, because of the many people working with the papers at the Longfellow House, not the least of whom was Henry Wadsworth Longfellow Dana himself, there is a certain amount of intermingling between collections. Materials from the *Elizabeth Ellery Dana Personal Papers* have been removed to, taken from, or reference similar topics as the collections listed below.

LONG 21808:

Dana Collected Correspondence, 1808-1938 (Bulk Dates 1857-1934). EED was the primary force behind the accumulation of this collection. She not only saved her own correspondence but that of family members, including her mother Sarah (Watson) Dana (1814-1907), her siblings, and others. The collection contains this correspondence along with related items such as newspaper clippings, natural history specimens, objects and photographs that were all enclosed with various letters throughout the collection.

LONG 27037:

Dana Family Papers, Collected Manuscripts, Genealogies, and Research Materials, 1661-1960 (bulk dates 1750-1940) is a collection of papers amassed by Elizabeth Ellery Dana (1846-1939) and Henry Wadsworth Longfellow Dana (1881-1950) through the course of their research and writing of *The Dana Family in America*. The collection contains subcollections: I. *The Dana Family in America* Records and II. The Dana Family: Research and Collected Manuscripts. This collection contains little personal material related to EED; however, EED conducted a great deal of research on the Dana Family and related subjects and those materials along with the publication records for this book are a part of this collection.

LONG 17314:

Henry Wadsworth Longfellow Dana (1881-1950) Papers, 1744-1972. EED's research notes on Two Years Before the Mast and correspondence with HWLD are in this collection.

LONG 27883: Richard Henry Dana III (1851-1931) Papers, 1797-1947

(bulk dates: 1860-1915). This collection contains research about RHD III by EED and HWLD and many letters by

RHD III to EED.

LONG 16173: Papers of Alice Mary Longfellow (1850-1928), 1855-1965

(bulk dates: 1873-1928). The correspondence series in AML's papers includes outgoing correspondence to EED.

LONG 27930: The Longfellow Family Papers include correspondence

written to EED by members of the Longfellow Family

especially Edith Longfellow Dana (1853-1915).

SUBCOLLECTION AND SERIES DESCRIPTIONS

SUBCOLLECTION I. HWLD COLLECTED MATERIALS

The first subcollection contains materials collected by HWLD relating to EED's last years, her final illness, and subsequent death. The materials in this collection were not found in original order. The provenance of *Subcollection I. HWLD Collected Materials* was easily distinguished since it was collected by HWLD after EED's death and much of the correspondence was written to him. Most of the series is arranged alphabetically by correspondent to promote access. The rest of the materials were arranged by date to show the order of events.

This subcollection is arranged into three series as follows:

Series A. Collected Materials. The collected materials consist of correspondence concerning EED and her last years. It contains EED's bequests, church pledges, and a diagnosis of her final illness.

Series B. Obituaries and Memorials. The posthumous materials contain EED's obituaries and a memorial written by HWLD.

Series C. Correspondence. This is a collection of correspondence responding to the news of EED's death and correspondence having to do with the arrangements for her funeral and burial.

SUBCOLLECTION II. PERSONAL PAPERS

The second subcollection contains material created or collected by EED during her lifetime and appears to be representative of her active character. The materials in this collection were not found in original order. Most of the materials were arranged by date; the correspondence is arranged alphabetically by correspondent. If the arrangement differs in the sub-series, the difference is noted in the descriptions below. The subcollection is arranged into thirteen series as follows:

Series A. Personal Materials. The personal materials sub-series contains a single diary for the year 1869 and "The Longfellow Textbook and Birthday Record."

Series B. Correspondence. The correspondence contains outgoing and incoming correspondence primarily with family members, including EED's father, Richard Henry Dana, Jr. (1815-1882). A letter from John T. Morse, a friend of RHD, Jr., speaks of him highly as a lawyer of the "slavery-case." Notable correspondents also include Julia Ward Howe.

Series C. School. The School sub-series contains various exercises and essays written by EED during her years at Miss Porter's School and Cambridge High School. An essay, written by EED as a high school student, mentions Henry Wadsworth Longfellow.

Series D. Travel. The travel sub-series contains correspondence from EED to her family and materials collected by her while she traveled in the United States and abroad in Europe with her family. Materials include correspondence, menus, maps, and photographs.

Series E. Notes and Notebooks. These notes and notebooks probably represent a small fraction of the total number of materials written by EED during her lifetime. They contain various lists including Dana jewelry, china and silverware, lists of furniture EED donated to the Colonial Dames and lists of other Dana family possessions.

Series F. Financial Records. The Financial Records series is further divided into EED's expense records, bills and receipts, tax documents, insurance correspondence, bank records and investment materials. The materials date mainly from EED's later life. Most of the records in this sub-series are arranged by office of origin of the record and then by date.

Series G. Legal Records. Legal records consist of various documents but most notably there is EED's agreement providing funding for the publishing of the Dana family genealogy (1936), her instructions for her funeral and burial, and a copy of her will.

Series H. Estate Records. The estate records contain correspondence between EED's executors and her family concerning her will and the allocation of her possessions.

Series I. Writing and Research. The writing and research consists of correspondence and notes concerning the book, *The British in Boston*. The subseries also includes her correspondence with the publishing company, Harvard University Press. Other materials in this series represent just a fraction of EED's wide-ranging genealogical interests including research into the Watson and Willard families. The majority of EED's genealogical interests are represented in the *Dana Family Papers (LONG 27037)*.

Series J. Organizations. This sub-series is dominated by EED's materials from the Colonial Dames, of which she was a member for many years and materials from "The Bee" to which she belonged from her teenage years. The series also includes correspondence related to EED's involvement with Society for the Preservation of New England Antiquities (SPNEA), the Episcopal Church and the Cambridge Historical Society, which her brother, RHD III, served as president. The Handel and Haydn programs including an 1869 broadside of a Beethoven centennial concert are of special interest.

Series K. EED Collected Materials. The Collected Materials consist of a wide variety of items that she accumulated over the years. EED was an avid newspaper clipper and she held onto many pieces of information. The collection also includes EED's calling cards.

SUBCOLLECTION III. PHOTOGRAPHIC MATERIALS

Includes photographs related to Elizabeth Ellery Dana (1846-1939), her family and her interests.

If the photograph was found with manuscripts in the collection, the cataloger noted the photograph's original location in the "Summary Notes" field in the Item level record.

Photographs that were separated from the collection in anticipation for the FY 1999, 2000 Photos cataloging project are in this group. In addition, other photographs that were found already separate from the papers were processed in the Photos cataloging project as part of these papers. Records in the accompanying Interior Collections Management System (ICMS) database describe the photographs at the item level. The full records are available at the site's archives, and selected fields comprise the descriptions in the photographs' finding aid, *Addendum: Photographs in the Elizabeth Ellery Dana* (1846-1939) Personal Papers, 1829-1940, Richard Henry Dana III (1851-1931) Papers, 1797-1947, Dana Collected Correspondence, 1838-1938, and Dana Family Papers, 1661-1960.

Elizabeth Ellery Dana ["Lily"] was born on 3 April 1846, the third child of Richard Henry Dana, Jr. (1815-1882) and Sarah Watson Dana (1814-1907). Elizabeth Ellery Dana was named after her great-grandmother who was the daughter of William Ellery, a signer of the Declaration of Independence. She was educated at Miss Porter's school in Farmington, Connecticut, and graduated from the Cambridge High and Latin School.

When the Civil War began in 1861, Miss Dana was fifteen years old. She and a group of her friends formed a sewing circle to benefit the soldiers. This group, originally known as "Banks' Brigade" (Banks was a Union general), soon became known simply as "The Bees" or "The Bee." Members of the group continued to meet throughout their lives as a social circle and charitable group. In many of Miss Dana's letters, references were made to hosting "a Bee" or going to "a Bee." She sang with the Handel and Hayden Society for many years and mentions their rehearsals and concerts in her diary and correspondence. Based upon her descent from Anne Bradstreet and Gov. Thomas Dudley, she became a member of the Massachusetts Society of the

Colonial Dames in 1897. Miss Dana was a communicant of the Church of the Advent, Boston and Christ Church, Cambridge.

In 1865, Miss Dana read a short Dana genealogy published by John Jay Dana and became interested in the subject. For the remainder of her life, she devoted herself to research in England and America and worked to compile a complete and accurate genealogy of the Dana family. During her research, she came upon an unpublished diary of a British officer who was stationed in Boston during the Revolution, and in 1879 she edited and published excerpts from this diary in the *Atlantic Monthly*. In 1924 she edited and published the diary in its entirety. The book, *The British in Boston*, was printed by Harvard University Press. She also contributed to *A Historic Guide to Cambridge*, issued in 1907, and to the genealogical column of *The Boston Transcript*. She was a member of the New England Historic Genealogical Society and the Cambridge Historical Society and contributed to their journals. Miss Dana also researched General James Dana and the battle at Bunker Hill during the Revolution. She published an article "Lt. James Dana at Bunker Hill" in 1911.

Miss Dana was also interested in her mother's family, the Watsons and the Daggetts of Wethersfield, Connecticut. With the aid of William Watsons's journals, ledgers, letters and extracts, Miss Dana published "Vital Records Kept by William Watson of Hartford Conn., 1819-1834" in *New England Historical and Genealogical Register* [p. 150], April 1925 and "Extracts from the Diary of William Watson of Hartford, Conn., 1819-1836" in *New England Historical and Genealogical Register* [p. 298], July 1925.8

The Dana genealogy, meanwhile, progressed very slowly. Miss Dana always seemed to be on the verge of publishing it, even taking subscriptions in 1930. She wrote her own obituary and mentioned the work, saying that it had been completed and would soon be published. Although there are page proofs of the book from 1930 and 1936, it was not finished until 1956, following further work by her nephew and grandnephew, Henry Wadsworth Longfellow Dana (1881-1950) and Henry Longfellow de Rham (b. 1905). When it appeared, the book was titled, *The Dana Family in America*, and Elizabeth Ellery Dana was credited as the sole author. 9

Although Miss Dana spent much time travelling, her primary residence for nearly her entire life was in Cambridge. She lived with and cared for her mother for twenty-five years after the death of her father. Following her mother's death, she lived at several locations, including 15 Appian Way and ultimately at 11 Mason St., usually accompanied by a companion. Most notable among these companions were Miss Mary Wood, Grace Freeman, and Mrs. C.W. Kennedy. She saved much of the correspondence sent to her throughout her life and collected many letters sent to her mother, sisters, aunts, grandmother, and other family members. Her work with her family's

genealogy led to an extensive correspondence with immediate family members and other distant relations. She employed several professional genealogical researchers for many years to help her. Her extensive collection of notebooks reflects her intensive and thorough research methods.

After her death her nephew, Henry Wadsworth Longfellow Dana, retained her personal papers and those she collected. Today these collections make up a large portion of the archives at the Longfellow House - Washington's Headquarters National Historic Site.

CHART I. DESCENDANTS OF RICHARD DANA AND LYDIA TROWBRIDGE




CHART II. DESCENDANTS OF RICHARD HENRY DANA JR. AND SARAH WATSON





CHART III. DESCENDANTS OF RICHARD DANA III AND EDITH LONGFELLOW

White moire endpapers, white cardboard pages, gilt leaf edges. Most photos annotated by Elizabeth Ellery Dana (1846-1939).

Images date from C1864-C1875 because of apparent age of subjects and general dating. Some of the window mats are empty including pre-cut windows annotated by EED as "Edith Longfellow" and "Annie Longfellow."

2. Album of Travel Prints Owned by Elizabeth Ellery Dana (1003.003/002-002)

Album of 99 albumen prints bought in Italy and France. Tan linen cover. Each photograph is glued to individual pages. Travel prints most likely purchased by Elizabeth Ellery Dana (1846-1939) and possibly her family while traveling in Rome, Italy. Most images are inscribed by EED, and this album most likely belonged to her.

Images date from C1879-C1882 when EED was traveling throughout Europe with her family.

3. Album Owned by Elizabeth Ellery Dana (1003.003/002-003)

Album including gelatin silver prints. 46 photographs. Reddish-brown cover with "Photographs" embossed in gold on front cover. Black endpapers and the same black paper used throughout album. Pre-cut window mat openings with square shape. Two window mats per page. Some mats are empty.

Images date from C1901-C1906. Unassociated letter from Richard Henry Dana IV (1879-1933) to Elizabeth Ellery Dana (1846-1939), June 8, 1905 removed from this album.
