PUBLIC CAMPING - PRIMITIVE	
Redwood National and State Parks	There are several walk-in camps in the parks. Stop at a visitor center for locations and conditions. Request a Backcountry Basics brochure. Use provided food storage lockers. For overnight trips into Redwood Creek, obtain free permit at the Kuchel Visitor Center in Orick. There are also backpacker sites available at Miners Ridge and Ossagon Creek in Prairie Creek Redwoods State Park. Register at Prairie Creek Entrance Station. No Pets On Trails.
Tolowa Dunes	Located north of Crescent City. 6 walk-in and 1 group horse site. Inquire at Jedediah Smith or Mill Creek campgrounds for fee and gate combination. Winter: ask at Jed or Crescent City Information Center.
Humboldt Lagoons	South of Orick. Self registration. Six stone lagoon environmental camps. Accessible by boat only. Pit toilets, picnic tables, fire pits, bear poles. (707) 488-2041
Smith River National Recreation Area (SRNRA)-Six Rivers National Forest	Unless specifically prohibited (such as South Fork boat launch site), primitive camping is allowed in most of SRNRA. You must camp at least one-quarter mile from developed campgrounds. There is a 30-day camping limit. Obtain free fire permit at Gasquet USFS office. Pack out all trash; bury human waste 6-8 inches deep and 100 feet from water; store food and scented items properly.
