#### EDUCATIONAL PROGRAMS AND OUTREACH

This fall, our Rangers were thrilled to be able to visit Henrico County Schools to hand out 1000 Every Kid Outdoors 4<sup>th</sup> Grade passes! These passes allow 4<sup>th</sup> grade students and their families to enter National Parks for free. Back in the parks, we hosted battlefield tours for youth groups including Scout packs and middle-school classes. We were also honored to have Secretary of Transportation Pete Buttigieg, Governor Ralph Northam, Senator Tim Kaine, U.S. Representatives Donald McEachin and Abigail Spanberger, and Mayor Levar Stoney visit the Maggie Walker site during their tour of Jackson Ward in early December.

#### NPLD 2021

National Public Lands Day was a big success! Volunteers planted 500 grass plugs on the earthworks at Totopotomoy Creek, which will reduce erosion and keep the area looking nice. These native grasses, including Purple Top and Little Bluestem, will also help prevent the spread of invasive Japanese Stiltgrass. Nationwide, more than 46,000 volunteers participated in 537 NPLD events.


### In Case You Missed It...

#### Fall Recap

#### **UNIT REFERENCE BINDER PROJECT**

Volunteers recently helped with an important project tied to visitor services. The battlefield visitor centers have Unit Reference Files, which list each unit from both armies and provide information on that unit's history, organization, and details of its participation in the battles. These aid visitors who are searching for ancestors or researching a certain unit or part of a battle. Over the years,

wear and tear have taken their toll, as the first photo shows! Ranger Mark Wilcox retyped all the data, and Ranger Bert Dunkerly reached out to volunteers to help organize and put together the new data sheets. An enthusiastic group stepped forward to assist and spent several hours over two days reorganizing the new materials. This project replaces a frequently used reference item and ensures that visitors many years into the future will be able to get the research assistance they need. Thanks to our great team for your help!

### Celebrating Your Work

#### ADOPT-A-TRAIL

Bill Linka, Jeanette Linka, and Bill Koetter have continued monitoring trails across Cold Harbor, Malvern Hill, and Gaines' Mill. We could not run our trail maintenance programs without their hard work and consistent input. Thank you!

#### CHIMBORAZO PATIENT PROJECT

Under the direction of Ranger Mike Gorman, researchers continue to work on the Chimborazo Patient Project from home. Volunteers work with either microfilm or use online sites like Fold3 to enter data from the original records and fill in gaps about patients, their illness, treatment, and service records. This will be an invaluable resource for genealogists and those studying Chimborazo Hospital. Thanks to the hard work of Jean Hemphill, Roger and Linda Hultgren, and Lorianne Stogsdill, we have fully processed over 20,000 patients! Recently the fourth reel of microfilm was transcribed (one more to go). About 70,000 soldiers passed through Chimborazo Hospital and we expect the project

to continue for several more years, but we're making great progress.

### Celebrating Your Work

#### Adopt a Monument

The battlefield park has four monuments, all of them adopted by various groups. They include:

- 2nd Connecticut Heavy Artillery Monument at Cold Harbor, adopted by the Richmond Civil War Round Table
- Wilcox Monument at Gaines' Mill, adopted by the 12th Virginia Reenactment group
- Texas Monument at Gaines' Mill, adopted by the Richmond Battlefields Association
- Parker's Battery Monument, adopted by the Civil War Buffs of Chesterfield County

These groups check on the monuments, clean up litter, wipe off dirt, and report on any issues to the park. This fall, three of the monuments were cleaned by volunteers and park staff. The Connecticut, Wilcox, and Texas monuments were all cleaned using water and a special gentle soap. The goal was to remove dirt, mildew, and moss. Using water, soap, and brushes, the groups gently cleaned the monuments, applying only enough pressure to remove the dirt and aiming not to harm the stone, brass, or inscriptions. Dear RICH and MAWA volunteers,

The Department of the Interior's (DOI) COVID-19 mitigation <u>policy bulletin</u> regarding access to federally controlled buildings for business visitors has been determined by DOI to apply to volunteers. This guidance aims to help all business visitors, including volunteers, stay safe in our national parks. Please read the below FAQs to familiarize yourself with this change.

Volunteers are an important part of the National Park Service and we are grateful for your continued service.

#### 1. What must NPS volunteers do?

All volunteers accessing NPS buildings must:

- Complete a <u>Certification of Vaccination form</u> (OMB Control No. 3206-0277) by January 10, 2022. If they have NOT attested to being fully vaccinated, they must also possess and present a negative COVID-19 test result from within the 3 days immediately prior to the date of entry; and
- Maintain completed form (and test result, if necessary) on their person for the duration of their visit and present it to the volunteer manager or supervisor, as needed; and
- Comply with all public health protocols in place at the park or office.

Volunteers who do not access NPS buildings, such as volunteers working outside, are only required to comply with other public health protocols in place, such as masking, social distancing, and hand washing.

#### 2. What requirements must be met for COVID-19 vaccinations?

A person is fully vaccinated 2 weeks after their second dose in a vaccine that uses a 2-dose series, such as the Pfizer or Moderna vaccines, or 2 weeks after a single-dose vaccine, such as the Johnson & Johnson vaccine.



#### 3. Where can I find out more about COVID-19 vaccinations?

You can find a vaccination location near you on <u>Vaccines.gov</u>, or by texting your ZIP code to 438829 to get a text with the closest COVID-19 vaccination location. If you have concerns about the vaccine, learn how you can find <u>credible vaccine information</u>, identify <u>myths and facts about COVID-19 vaccines</u>, and get answers to <u>commonly asked questions about vaccinations</u>.

# 4: Will the park or program where I volunteer collect, copy, or record information from my completed <u>Certification of Vaccination form</u>?

No. Volunteer managers and volunteer supervisors should read the responses on the form, but they should not take possession of the form or make any record of the information reported on the form.

# 5: What type of test is acceptable for entry to facilities in situations where evidence of a negative test is required?

Any viral test that detects infection that is authorized by the U.S. Food and Drug Administration (FDA) and produces a dated result is acceptable. An antibody test result is not acceptable. Test results from a pharmacy or a lab should be from FDA-authorized tests. If you have any doubts, please consult the FDA website to see lists of authorized <u>molecular</u> tests and <u>antigen tests</u>.

# 6: Are there exemptions for the requirements for volunteers to attest to their vaccination status and/or provide documentation of a negative test result?

Medical and religious exemptions are not accepted in place of the requirements for volunteers to attest to their vaccination status and/or provide documentation of a negative test result.

#### 7. Are volunteers under the age of 18 impacted by this policy?

Volunteers below the age of 18 should have a parent / guardian sign the Certification of Vaccination on their behalf, noting this on the "Your printed name here" line. Example: [Printed Name of Parent] signing on behalf of [Printed Name of Minor]. Everyone age 5 years and older is currently eligible for COVID-19 vaccination.

Volunteers consistently embody the spirit of service, engagement, and stewardship present throughout Richmond National Battlefield Park and Maggie L. Walker National Historic Site. Thank you for your service and for your help ensuring the safety of park visitors, employees, volunteers, and partners.
