Handwritten Pension Claim Affidavit August 1881

In the Claim of John Ridderman late of Co I 0th Ohio Infty [sic] No 207.069 – Invalid Pension

On this 3rd day of August AD 1881, personally appeared before me the undersigned a Notary Public for and within the County and State aforesaid John Ridderman, who is personally known to me and who after being duly sworn upon his oath deposes and says That he is the identical John Ridderman who is an applicant for pension, his claim filed as No 207.069 – being for and account of injuries received while in the service of the U.S. as a member of the 9th Company of the 9th Regt Ohio Infty [sic] while on detached service with Capt [sic] Hoeats [sic] battery 1st Ky

The the [crossed out] circumstances under which he contracted his disability is as follows to wit:

About a month before the battle of Stone [sic] river, also called Murfreesboro, on Dec 31, 1862 – he was detailed first as Guard with said battery and afterwards [illegible text] with said battery and was engaged in Said battle aforesaid as one of the gunners or Artillery men.

That the [illegible line of text] Captured all the gunners [illegible line of text] except those on which deponent was [illegible] and that this gun was saved to the Union on account of the exhertion [sic] of this deponent in hitching horses thereto and mounting the sadle [sic] horse [illegible] towards the Union line. on his way to the Union line the horse upon which he was riding was shot down, fell and the wheel of the gun wagon passed over the right foot near ancle [sic], fractured some of the bones, dislocating ancle [sic] and badly bruised his said foot and leg. The horses passed on and his gun was saved.

All of the men engaged on said battery were killed or captured or had retreated without their guns, he was a stranger to all and has not seen any one since.

Deponent was taken off of the field of battle, treated for his wound by unknown US Surgeons, and sent to US. Hospital at Nashville Tenn. where he remained several weeks, (name of Hospital not Known) then was sent to his Regiment where he remained a few days, perhaps ten days, and then sent in an ambulance to Murfreesboro where he remained some 8 days, was treated for his wound and after a [illegible] examination by a board of Surgeons sent to Convalescence Camp at Nashville Tenn where he remained about a week and was re examined by a board of US Surgeons and then assigned to Co "C" Capt [sic] Schmidt 15th U.S. Infantry, being

1st US. Invalid Corps and wherein he served till the 21 day of May 1864, when he was discharged.

Since his discharge aforesaid he served in no other military or naval service.

His said injury is a permanent one, permanently dissabling [sic] his ancle [sic] and foot disqualifying from manual labor, and medical aid is useless, except that off and on uses liniments to relieve pain and inflamation [sic].

He has been engaged as a farmer since the war, yet he is and always will be unable to perform all Kind of labor requiring [illegible] foot, on account of said injury.

A great portion of the time he is entirely disabled to work, and at [illegible] he can do light work such as will not require use of his said foot.

From the history of the case, it must appear that deponent can not furnish evidence of Officers and Comrades showing occurance [sic] of his injury. The records of the was department and of said battery, etc., deponent supposes to contain the [illegible] and perhaps show the faithful service, with valor [illegible line of text] as was actually performed [illegible words] by deponent.

Deponent has revoked all letters of power of Attorney to parties claiming to represent him and offered to pay for whatever compensation such Agents may be entitled to for services rendered and he desires to have all papers and communication in relation to his claim sent to him at Glasgow Missouri which is his Post Office address!

years, a resident of [blank] in the County of Chariton and State of Missouri whose Post Office address is Cazzell Mo well known to me to be reputable and entitled to credit, and who, being duly sworn, declare in relation to the aforesaid case as follows:

[Affiants should state how they gain a knowledge of the facts to which they testify] we have known the Claimant John Ridderman Four years. we know him to be Cripled [sic] in his right foot which we are informed was Caused while he was in the US Service.

But we have personal knowledge as to his injury in his left leg and hip which injuries were Contracted without fault of his own.

On August the 20 day 1900 Said Riddleman was Patching some Plastering overhead in School House and while at work fell from a scaffold and struck a stove with his left leg and hip and Broke it and we Picked him up and Carried him and put him on a bed in the front part of School House.

Name not borne on rolls Co "G" 9th Ohio Vols.

There is no Youatts or Hoeats Battery Ky. Art'g, [sic] known to this office. Battery "B" (Capt. Hewitt) Ky. Lt. Arty was engaged at the Battle of Stone [sic] River, Dec 31/62.

John Ridderman or similar name, is not borne on the rolls of said battery from Sept. 1st, 1862 to Feby 26/63.

The records of this office furnish no evidence of alleged injury at Stone [sic] River Tenn Books of the Battery not on file.

There are no records of the Post or U.S. Forces at Nashville Tenn, covering date, on file.

That she is the widow of John Ridderman who was [illegible directions] Enrolled under the name of John Ridderman at not known on the [blank] day of [blank], 18[blank] as a [illegible directions] Private in Company H 9th Ohio Regiment and honorably discharged

not known having served ninety days or more during the late war of the rebellion. That the soldier was not in the military or naval service of the United States except as stated above. [illegible directions]

That she was married under the name of Anna Boeckmann to said soldier at Faus Dulman Germania on the 5th day of September 1871 by Rev. Wm Rulle; that there was no legal barrier to the marriage, that she had not been previously married: that the soldier had not been previously married. [illegible directions]

That the said soldier died Sept 25th 1907, at Aholt Mo. that she was not divorced from him; that she has not remarried since his death: and that she is without other means of support than her daily labor and an actual net income not exceeding two hundred and fifty dollars per year.
