ON THIS 31st day of January A. D. one thousand eight hundred and eighty 8 personally appeared before me a Clerk of the Circuit a Court of Record within and for the county and State aforesaid Daniel Ganger age 44 years, who, being duly sworn according to law, declares that he is the identical Daniel Ganger who ENROLLED on the 16th day of October, 1861, in Company K of the 57th regiment of Ind Inf Vols commanded by Capt [sic] Edwin L Billings for 9 months and was honorably DISCHARGED at Hillsborough Tenn. on the 30th day of July, 1865; That his personal description is as follows: Age 18 years; height 5 feet 10 1/4 inches; complexion Fair hair Light; eyes Blue That while a member of the organization aforesaid, in the service and in the line of duty at Stone [sic] River in the State of Tennessee, on or about the 31st day of December, 1862, he [Here state the name or nature of disease, or the location of wound or injury. If disabled by disease state fully its cause, if by wound or injury, the precise manner which received.] Incured [sic] a severe Exposure to inclement weather, taking a severe cold which brought on Rheumatism which became chronic, and has continued ever since. During

the fight at Stone [sic] River He became heated and over worked. It rained the last day of the fight as he remembers it and himself and a comrade had to lay that night only in their blankets, and when they were awakened in the morning the water was surging all around them. From this time on applicant was troubled with pain in his limbs and upon any slight exposure or change of the weather he would suffer and during his Entire service Thereafter and since up to the present time.

That he was not treated in any hospital [crossed out as follows:]

[Here state the names or numbers, and the localities of all hospitals in which treated and the dates of treatment.] He used to get Medicine of Regimental Doctor for it. At Savannah Geo He was unfit on his account for duty and they were going to send him by boat to Atlanta. But at his Earnest request they let him stay with the Regt. and put his gun on the wagon

That he has been employed in the military [crossed out: or naval] service otherwise than stated above [Here state what the service was, whether prior [crossed out] or subsequent to that stated above, and the dates at which it began and ended. after the above term service, he reenlisted as a veteran – was enrolled in Co. I. 22d Regt Ind Vet Vols Ind Inf. Jan 4th 1864, Discharged July 24th 1864

That he has not been in the military or naval service of the United States since the 24th day of July 1864

That since leaving the service this applicant has resided in the [crossed out] Elkhart County in the state of Indiana, and that his occupation has been that of a Farmer and Miller

That prior to his entry into the service above named he was a man of good, sound, physical health, being when enrolled a Farm Laborer. That he is now one half disabled from obtaining his subsistence by manual labor by reason of his injuries, above described, received in the service of the United States; and he therefore makes this declaration for the purpose of being placed on the invalid pension roll of the United States. He hereby appoints with full power of substitution and revocation. Joel H Austin of Goshen Indiana his true and lawful attorney to prosecute his claim. That he has not received nor applied for a pension; that his residence is the [crossed out] Elkhart Township Elkhart Co. Ind and that his post office address is Goshen Ind.
