- 4. June 1863 Skirmishes at Middleton and Liberty Gap, Tennessee
- 5. Sept 19, 20, 1863 Battle of Chicamauga [sic], Tennessee
- 6. <u>Numerous</u> other engagements in Alabama, Georgia, South and North Carolina until the Regiment was mustered out on July 20, 1865 at Lexington, North Carolina

Occurances [sic] during period of service:

- 1. Jan and Feb 1862 Detailed form unit to act as hospital cook at Munfordsville, Kentucky
- 2. Wounded in the hip at Battle of Stones River, Tennessee on Dec. 31, 1862 and hospitalized in Nashville, Tenn. until April 10, 1863
- 3. Re-enlisted at Tyners Station, Tennessee on Feb. 19, 1864 for 3 years entitled to a re-enlistment bounty of \$300 for 3 years
- 4. On discharge from his unit he kept his army Colt's revolver and paid \$8.00 for it

Discharged: At Lexington, North Carolina on July 20, 1865

Period of Service: August 29, 1861 to July 20, 1865 (3 years, 10 months and 22 days)
