He was born Gustav Kasten on October 30, 1841, in Bergin, Rugen, Prussia to Karl Bernhard and Marie Juliane Kasten. He immigrated to Grafton, Wisconsin, in 1857. he enlisted in the Union Army on August 20, 1861, and was in Company E of the 36th regiment of the Illinois Volunteers. He died December 31, 1862, at the Battle of Stones River.
