CERTIFICATE OF DISABILITY FOR DISCHARGE.

Logan Knowles a Private of Captain Bennett's Company, (F) of the 73rd Ills Regiment of [United States is crossed out] Vol Infty [sic] was enlisted by Gus Montgomery of the [blank] Regiment of [blank] at Middletown Ills on the 9th day of August 1862 to serve 3 years; he was born in Gibson co in the State of Indiana is 36 years of age, 5 feet 4 inches high, Dark complexion, Dark eyes, Black hair, and by occupation when enlisted a Farmer During the last two months said soldier has been unfit for duty [blank] days. [see first footnote below]

Sir:

I have the honor to acknowledge the receipt from your Office of application for Pension No. 230,367, and to return it herewith, with such information as is furnished by the files of this Office.

It appears from the Rolls on file in this Office that Logan Knoles [sic] was enrolled on the 9 day of August, 1862, at Menard, in Co. F, 73 Regiment of Illinois Volunteers, to serve 3 years or during the war, and mustered into service as a Private on the 21 day of August, 1862, at Camp Butler Ills, in Co. F, 73 Regiment of Illinois Volunteers, to serve 3 years, or during the war. On the Muster Rolls of Co. F, of that Regiment, for the months of [crossed out] from muster in to Feby 28th, 1863, he is reported [illegible] Present. Roll for March - April 1863 reports him, In convalescent camp Murfreesboro Tenn, [sic] since March 11, 63. Roll for May and June 1863 reports him Present, Roll for July and Augt. [sic] '63 reports him, Sick in Co. quarters Roll for Nov. and Dec. 1863 reports him Discharged by reason of surgeons [sic] Certificate Oct 22 - 1863 Louisville Ky

Cert. of Disability reports him dischd. [sic] at "Louisville Ky. Oct 21st 1863" which date is accepted as correct.

AFFIDAVIT.

Now came J C Lloyd and William H Stevens residents of the aforesaid county and state whom I certify to be respectable and entitled to credit, and who, being by me first duly sworn, according to law, do [blank] depose and say, That they were members of Company "F" in the 73rd Regiment of Illinois Infty. [sic] Vols. War of 1861 and certify that they were acquainted with Logan Knoles [sic] of said Company, and that he caught cold at the battle of Stone [sic] River (also called Murfreesboro) in the State of Tennessee while in the line of his duty, on or about the 31st day of December A.D. 1862, which cold settled upon his lungs and that he was weak and sickly subsequent to that time and they further say that their knowledge of the above facts is obtained from the following source, viz: personal knowledge and observation as they were present with him at the time and that they have no interest and are not concerned in the prosecution of his widow's claim for a pension.
