DECLARATION FOR INVALID PENSION.

On this 1st [30th is crossed out] day of March 1864, before me, the undersigned, John S [illegible] Clerk of the County Court in and for the County and State above named, and by law duly authorized to administer oaths for general purposes, personally appeared John J Miles who, being duly sworn according to law, declares that he is aged Twenty Six years, and is a resident of Kelley Township [illegible], in the State of Illinois and that he is the identical John J Miles who was a Private in Company "C" commanded by Captain John Russell in the 44th Regiment Illinois Volunteers, commanded by Colonel Blake Knobelsdorff; in the war of 1861 and 1862, for the suppression of the Rebellion in certain States of the Union, and for the maintenance of the Federal Government, and that he has not in any way been engaged in, or aided or abetted the exiting Rebellion in the United States. That he volunteered as above stated at Wenona, in the State of Illinois on or about the First day of July, 1861, for the term of Three years, and was honorably discharged at Indianapolis Indiana on the 22d day of January, 1864, as will appear by his certificate of discharge [herewith presented is crossed out] in his posesion [sic]

That while in said service and in the line of his duty at Stone [sic] River in the State of Tennesee [sic] on the Thirty first day of December 1862 [see footnote below] while engaged in battle with the enemy was wounded by a ball striking him on the right sholder [sic], since receiving said wound his general health is not good

On or about the 3d day of December 1863, he was transferred [sic] to Company 109 1st Battalion of Invalid Corps with out his [illegible], and discharged therefrom by reason of surgeons [sic] certificate.

That since leaving said service this applicant has resided in Kelley Township [illegible] Co III and his occupation has been nothing.

He makes this declaration for the purpose of being placed on the Invalid Pension Roll of the United States, by reason of his disability above stated; and hereby constitutes and appoints John C Stewart Galesburg Illinois his Attorney to prosecute this claim, procure a Pension Certificate, and semi-annually to receive and receipt for his Pension from this Pension Agent.

Peterson USA is Presedant [sic] said soldier has not been able to perform duty during the last two months on account of a gun shot wound in Right shoulder
