Discharge Certificate

I certify, on honor, that Robert D. Napier a Sergeant of Captain Starling's Company (C.) of the 9th Regiment of Infantry VOLUNTEERS, of the State of Kentucky, born in Allen County, State of Kentucky, age 23 years; 5 feet 8 inches high; Fair complexion, Gray eyes, Light hair, and by occupation a Farmer, having joined the company on its original organization at [crossed out] in Allen County Sept. 15/61 and enrolled in it at the muster into the service of the United States at Columbia, Ky, on the 26th day of November, 1861. [the following lines are crossed out: (or was mustered in service as a recruit by, [blank] at [blank], on the [blank] day of 186[blank], or was drafted and mustered into the service of the United States from the [blank] Enrollment District of the State of [blank], at [blank], on the [blank] day of, 186[blank], to serve in the Regiment, for the term of three years: and having served HONESTLY and FAITHFULLY with his company in Miss, Ala., Tenn and Ky to the present date, is now [crossed out: entitled to a DISCHARGE by reason of] Was killed in battle of Stones river December 31st 1862.

The said Robert D. Napier was last paid by Paymaster Harlton to include the 31st day of August, 1862, and has pay due him from that time to the present date; he is entitled to pay and subsistence for TRAVELING to place of enrollment, and whatever other allowances are authorized to volunteer soldiers, drafted men, or militia, so discharged. He has received from the United States CLOTHING amounting to 58.00 dollars, since the 15th day of September, 1861, [crossed out: when his clothing account was last settled]. He has received from the United States [blank] dollars never settled advanced BOUNTY.

There is to be stopped from him, on account of the State of [blank]; or other authorities, for CLOTHING, etc., received on entering service, 00 dollars; and other stoppages, viz: [blank]
