# Orlando Wells Nash Military Records

### Civil War Soldier Headstone Dedication

The public is invited to attend a Memorial Service for dedicating the newly-installed headstone for Civil War soldier, Orlando Wells Nash. The Memorial Service will be held on Sunday, May 22, 2005, at 2PM at the Lake Avenue Cemetery, Crystal Lake.

Orlando Wells Nash was born October 22, 1839 in Ohio. He was the son of Enos B. and Catherine Keller Nash. The family moved to Illinois in the 1840's, and eventually settled in Crystal Lake, Algonquin Township.

In September, 1861, at the age of 22, Orlando left his family farm and enlisted for a three-year term in the Illinois 36th Infantry Regiment, Company H at the rank of Private. Company H was commonly known as "The Woodstock Rifles". The 36th Infantry Regiment wintered in Missouri, and proceeded into Arkansas to fight at the battle of Pea Ridge in March, 1862. The Regiment then moved on to Kentucky and was involved in several skirmishes, including the Battle of Perryville. On November 14, 1862, Orlando was promoted to the rank of Corporal.

By December, 1862, the 36th Infantry Regiment had moved to Murfreesboro, TN. And on December 26th became engaged in the Battle of Stones River. On December 31, 1862, Orlando Wells Nash was killed at the Battle of Stones River.

The following excerpt is taken from a letter written on January 10, 1863 by Pvt. John H. Sackett of Hebron, who fought in the same regiment and company as Orlando Nash. Pvt. Sackett recalls and describes the Battle of Stones River: "You have in all probability before this heard of the great fight at Murfreesborough [sic] or Stone's [sic] River, 27 miles from Nashville, Tenn. We marched the next day after Christmas and skirmished until Dec. 30 when the fight began in good earnest and there was heavy artillery fighting all day. We gained considerable ground but the next morning the rebs [sic] had been reinforced from Chattanooga and they overpowered us and drove us back and ent [sic] our men up pretty badly. Our men fell back to the heavy cedar timber and there made a stand and fought until the 2nd of January when they evacuated Murfreesboro and left the place in our hands."

Several weeks later, a small group of local citizens, led by Mr. John Brink, traveled to Tennessee to claim the body of Orlando Nash and bring him back to Crystal Lake for burial.

In February, 1863, church services for Orlando Nash were held at the First Congregational Church, and he was laid to rest at the Crystal Lake Cemetery (now known as Lake Avenue Cemetery).

It is unknown if Orlando Nash's grave ever had a headstone; but the new government-issued Civil War era headstone will now mark the final resting place of this Civil War soldier, who died defending the Union.

A GIRL OF THE CIVIL WAR by Martha Josephine Buck Harwood

This diary was written by Martha Josephine Buck, who lived on a farm in Algonquin Township near Crystal Lake. The Buck family moved from Elmira, Chemung County, New York to Crystal Lake in 1944. Martha provides us with a genealogical record of the Buck family, as well as a description of her life in Crystal Lake between 1844 and 1863.

The Buck family were members of the First Congregational Church of Crystal Lake. In November 1863, Martha marries the church minister, Rev. James Harwood. Beginning with January 8, 1863, Martha begins to keep a detailed diary which provides us with an engrossing and lovely story of life in Crystal Lake over a century ago.

Her diary entry of February 5th 1863 provides some insight into the circumstances of the burial of Orlando Wells Nash, a Civil War soldier, who was killed at the Battle of Stones River at Murfreesboro, Tennessee

Entry dated February 5th, 1863

Thursday, February 5th 1863. It has been snowing nearly all day, -- and I think if we make a great deal of haste abut [sic] it, we can manage to get a sleighride yet this winter. It can't be possible for it to last a great while. This has been a pretty busy week so far. I feel in my bones that it has. Tuesday the funeral of Orlando Nash took place. The corpse arrived the day before. It had been buried about 3 weeks when Mr. Brink got there. He gave \$90 for a metallic coffin and had the body taken up and brought home. It looked quite natural even after so long a time so those say who saw it. The coffin was not opened at the Church. There was a great crowd there. Mr. Harwood delivered an excellent discourse on the occasion.

# Genealogy of Orlando Nash

Orlando Wells Nash was born on October 22, 1839, in Ohio. He died on December 31, 1862, at the Battle of Stones River, Tennessee. He was buried in February, 1863 in Crystal Lake Cemetery, Crystal Lake, Illinois.

Orlando's parents were Enos Nash and Catherine Keller. Enos Barnard Nash was born July 13, 1809 in Massachusetts, and died in 1894. He married Catherine Keller on November 6, 1838. She was born about 1818 in Pennsylvania and died in 1893.

Orlando's grandparents on his paternal side were Enos Wash and Sarah Wells. Enos was born on February 10, 1775 and died November 3, 1823. He married Sarah Wells on February 21, 1797. She died in August of 1848.
