Application for Pension Form

I, Dudley Tipps, a native of the State of Tennessee and now a citizen of Tennessee, resident near Mulberry, in the County of Lincoln in said State of Tennessee, and who was a soldier from the state of Tennessee in the war between the United States and the Confederate States, do hereby apply for aid under the Act of the General Assembly of Tennessee entitled "An Act for the benefit of the indigent and disabled soldiers of the late war between the States, and to fix the fees of attorneys or agents for procuring such pensions, and fixing a penalty for the violation of the same." And I do solemnly swear that, while in the discharge of my duty in the service of the Confederate or United States, as a member of Company E 17th Tenn [sic] Infantry CSA I was wounded in the battle or battles of Murfreesboro Tenn [sic] and from the effects of such wound or wounds I was disabled as follows: in my right hip by bursting of a bomb shell. I was captured at or near [illegible] Tenn [sic] by Yankee cavalry on Braggs [sic] retreat [illegible] [illegible] Tenn [sic] and was sent North to prison and remained a prisoner til [sic] the war closed and that by reason of such wound and disability I am now entitled to receive the benefits of this Act. I further swear that [illegible] hold any national, State or County office, nor do I receive aid or a pension from any other State, or from the United States [illegible] I am not an inmate of any soldiers' home, and that I am unable to earn a reasonable support for myself and family. I [illegible] solemnly swear that the answers given to the following questions are true:

In what battle or battles were you wounded, and if not in battle, state under what circumstances you received the wound or injuries? Answer: Murfreesboro – right hip joint by bursting of shell

What was the precise nature of your wound or wounds? Answer: shell bursting and fragment hit my right hip [illegible] shattered the breach of my gun into fragments which [illegible] and [illegible line of text]

What limb, if any, did you lose by reason of said wound or wounds, and, if no limb, state fully the disability caused by said wound or wounds, and is said disability permanent? Answer: no limb but the small of my back was permanent [illegible] and I am incapable of doing much physical labor

Were you incapacitated for service by reason of said wound, wounds, or service? Answer: yes

Were you discharged from the army by reason of said wound, wounds, or service? Answer: Captured while disabled but had returned to [text cut off]

How did you get out of the army? Answer: Discharged from Prison after the close of the war. While in prison had errispelas [sic] in my right [illegible] leg and it settled in my ankle joint from which I am now suffering

Did you take the oath of allegiance to the United Sates Government? Answer: I took the parole oath like Lee T Johnson [illegible] did after the war was closed.

If so, when, and under what circumstances? Answer: I was discharged from prison by taking [cut off]

I, Jane R. Tipps, do make and publish this as my last will and testament. First, I direct my funeral expenses and all my debts to be paid as soon after my death as possible out of any moneys that I may die possessed of or may first come into the hands of my executors.

Second, I direct that my real estate wich [sic] consist of 23 acres of land moreorless [sic] and lying in the 4th Civil District of Lincoln County be put up and sold to the highest bidder, and the proceeds from said sale be equally divide among my heirs, after my executors have put a substantial monument at the head of my and my husbands [sic] grave and also to the graves of Emma' Nora! Henry' and Davis Tipps [sic] grave

My heirs are Albert Tipps Nannie Copeland Will Tipps, Charlie Tipps, and the children of Davis Tipps Deceased namely Ray Tipps, Beuna V Tipps, Clifford Tipps Fannie May Tipps, Mary Lee Tipps, Terrace Tipps and Jennie [illegible] Tipps. The children of Davis Tipps are to have one share divided equally among them. I also direct that my family grave yard where there's already a grave yard started in my garden and to run out to the public road.

Lastly I do herby [sic] nominate and appoint W.G. Tipps and Charlie Tipps my executors, and [illegible] in them the power to Sell and make a deed to my lands and also power to sell all my personal property and divid [sic] the same as directed herein and I direct my executors to make Bond as the law requrs. [sic] Jane R. Tipps her mark Signed and published in our presence, and we have subscribed our names hereto in the presence of the testator, this the 25th day of September 1916.

There is only one class od Widows pensionable.

Widow must have married prior to 1890.

To be eligible the applicant must have remained a widow after the death of her soldier husband to be indigent.

Read the questions in the application carefully and answer them fully.

Read the law, and unless you come clearly under the laws it will be useless to file application.

The Boards meets on the second Tuesday in January, April, July and October.
