Inventory of the effects of Jonathan Tussey late a Private of Captain William Leonards [sic] Company I of the 38th Regiment of Indiana Infantry Volunteers, who was enrolled as a Private at Paoli in the State of Indiana on the 1st day of September 1861, and mustered into the service of the United States as a Private on the 18th day of September 1861, at Kawthoung Ind in Company I, 38th Regiment of Indiana Volunteers, to serve three years or during the war; he was born in Segoinsvill [sic] Tenn in the State of Tennessee; he was 18 years of age, 5 feet 6¾ inches high, Freckled complexion, Gray eyes, D. Brown hair, and by occupation, when enrolled, a Farmer; he died in General Hospital, at Murfreesboro Tenn [sic] on the 23rd day of March 1864, by reason of wounds received in the battle of Chicamauga [sic] Ga Sept 15th/63
