Dorothy and Harry B. Goodspeed, of Worcester, Massachusetts, visited Yellowstone National Park by rail in 1937. The couple had at least one daughter, Jacqueline or "Jacquie". It is possible Harry was a physician. Both Harry and Dorothy appear to have passed away in 1996 in Massachusetts.

DESCRIPTION Scrapbook of a trip by rail to Yellowstone National Park and the Canadian Rockies by Dorothy and Harry B. Goodspeed in 1937. The scrapbook consists of 11 loose pages of manila construction paper with photographs and ephemera affixed with glue.

Contents of the scrapbook include commercial photographs and postcards, personal snapshots, images clipped from magazines, small publications, and ephemera. The commercial photographs and postcards, primarily published by Haynes, Inc., include views of well known natural features such as Old Faithful Geyser, Morning Glory Pool, Yellowstone Lake, and the Grand Canyon of the Yellowstone as well as views of man-made features like the Canyon and Mammoth Hotels. There are also views of the Red Lodge-Cooke City Highway (now the Beartooth Highway) and the two communities. Personal snapshots include two views of Dorothy Goodspeed: one as she is boarding a Yellowstone Park Company yellow bus, the other an informal portrait. Other images depict the landscape along the road, Old Faithful Inn, and Tower Falls.

Clippings consist of animals such as bison and big horn sheep as well as Northeast Entrance and Silver Gate. Ephemera includes mementos of the trip such as menus from the Canyon and Mammoth Hotel dining rooms, a dinner identification card, a baggage tag, a book of Pullman tickets, railroad timetables, and a Northern Pacific Railroad brochure. Finally, there is an itinerary of the trip by Young's Travel Service of Worcester, Massachusetts, detailing stops and events, including the stops in Vancouver and Victoria, British Columbia, and Banff, Alberta. In total, the scrapbook depicts a classic rail tour of Yellowstone National Park during the early part of the 20th century.

ORGANIZATION The scrapbook remains in its original order.
