

YOSEMITE VALLEY MAINTENANCE AREA CONCEPT YOSEMIT



COAL: CONSOLIDATE AND RECONFIGURE MAINTENANCE AREA

ACTIONS:

- PEHAB EXISTING SEARCH AND RESCUE HEADQUARTERS AND CONSIDER ADDITION OF 1000 SF. TO AMBULANCE SHED.
- PORT BUILDING TO INCLUDE LAW ENFORCEMENT, VALLEY UTILITIES & ROAD OPERATIONS AND LIGHT MAINTENANCE FOR NPS AND CONCESSIONER.
- PECONFIGURE AND RESTRIPE PARKING AREA WORKING WITH AND AROUND ESTABLISHED TREES.
- PEMOVE SIGN STORAGE AREAS AND OTHER MISCELLANEOUS STORAGE SHEDS BEHIND FORT, CLEAN UP AND PARK LARGE EQUIPMENT AND SN OWPLOWS.
- PEMOVE PROJECT MANAGEMENT TRAILER, CONSIDER USING AREA FOR STORAGE OR ADDITIONAL PARKING.
- PRMOVE ALL BOUIPMENT FROM ARCHEOLOGICAL SITE, CLOSE OFF SMALL SPUR POAD, INSTALL PRVACY FENCE TO PROTECT ARCH SITE AND PROVIDE SEPARATION OF RESIDENTIAL AREA AND MAINTENANCE AREA. USE POADED FOR SHUTTLE BUS PARKING IN CONVUNCTION WITH LIGHT MAINTENANCE AREA.
- CONSIDER PLANTING TREES IN AND AROUND CORRAL AREA TO PROVIDE SHADE, MINIMIZE DUST AND DIMINISH THE VISUAL IMPACT FROM UPPER YOSEMITE FALLS TRAIL AND GLACIER POINT.
- PEMOVE MAINTENANCE EQUIPMENT FROM CHED BY CORRAL BARN AND USE FOR YEAR ROUND HAY STORAGE.

YOSEMITE LODGE CONCEPT

COAL: RECONFIGURE VEHICULAR, BICYCLE, & PEDESTRIAN CIRCULATION SYSTEMS WITHIN THE LIMITS OF THE EXISTING DEVELOPMENT AREA (AREA OF DISTURBANCE).

ACTIONS:

- ELIMINATE PEDESTRIAN, BICYCLE, & VEHICULAR CONFLICTS AT THE EXISTING INTERSECTION OF NORTHBIDE DRIVE & YOCEMITE LODGE POOD IE. PROPOSE PEDESTRIAN UNDERPISE ALONG WITH RELOCATION OF ROADWAY INTERSECTION.
- PRPURPOSE A SELECT SECTION OF YOSEMITE LOCKE ROAD DEDICATED TO VEHICULAR TRAFFIC, PROPOSE A PEDESTRIANIDICYCLE PROMENADE, RAMP THE PROMENADE DOWN TO THE UNDERPASS AT A MAXIMUM SLOPE OF 5%. THE PEDESTRIAN PROMENADE WILL BE CHARACTERIZED BY: ACCENT PAVING, LANDSCAPING, SITE RURNISHINGS, SITE LICHTING, & WAYFINDING CONSISTENT WITH THE DESIGN VOCADULARY OF THE YOSEMITE FALLS TRAL THE PEDESTRIAN PROMENADE WILL ALSO ACT AS THE INITIAL VIEW CORRIDOR TO THE YOSEMITE FALLS.
- PELCATE THE EXISTING TOUR BUS DROPOFT AREA TO THE NEW PAYED AREA DIRECTLY SW OF THE LODGE. IMPROVE THE VISITOR STAGING AREA & THE PEDESTRIAN CIRCULATION SYSTEM PROM THE DROPOFT AREA TO THE PEDESTRIAN PROMENADE TO MINIMIZE CIRCULATION CONFLICTS.
- ELIMINATE THE EXISTING CONCESSIONER EMPLOYEE HOUSING DIRECTLY SW OF THE LOCKE, REPLACE (60) REGIONICES WITH (16) UNITS ALLOCATED DETWEEN THREE (5) NEW BUILDINGS, ALL WITHIN THE EXISTING DEVELOPMENT AREA PROVIDE SEVENTY EIGHT (16) NEW PARKING GRACES IN PROXIMITY TO EACH BUILDING.
- ELIMINATE LINEN STORAGE AND LANNORY BUILDING & WELLNESS CENTER EXPAND THE EXISTING LODGE FOOTPRINT TO THE SKI. CONSCLIDATE THESE FUNCTIONS AT THIS LOCATION, ALONG WITH ASSOCIATED PARKING & SERVICE AREA.
- PROVIDE À NEW, DESIGNATED TOUR BUS, SHUTTLE BUS, & RV ACCESS OFF NORTHSIDE DRIVE.
- PROVIDE NEW, DESIGNATED PARKING FOR (15) TOUR BUSES, & (35) RVG.
- ADD (41) NEW PARKING SPACES & (97) NEW OVERFLOW PARKING SPACES TO THE EXISTING GAMP 4 PARKING.
- ADD A NET (25) NEW PARKING GRACES THROUGHOUT THE YOSEMITE LODGE GUEST RARKING AREAS.
- PREMOVE & CONSOLIDATE THE EXISTING ONSITE STORAGE AREA TO THE NEW LOCATION, RESTORE THE EXISTING STORAGE AREA.
