On August 3, 2018, I, Special Agent (b)(6)(7)(a)(e), United States Forest Service (USFS), conducted a laser scan of two areas of interest in the CARR Fire investigation. The National Park Service (NPS) and other investigators assigned to the fire requested a laser scan of areas of interest at the CARR Fire origin. The CARR Fire reportedly started on July 23, 2018 along CA Highway 299 west of Redding, California within the Whiskeytown National Recreation Area.

NPS Investigative Services Bureau (ISB) (b)(6)(7)(a)(e) and USFS Fire Investigator (INVF) (b)(6), (b)(7)(C) provided me background information on the fire investigation. INVF showed me the origin and ignition areas she identified during the origin and cause (O&C) examination. I scanned the origin areas identified in the O&C as Origin Area A and Origin Area B.

I conducted the scan using a FARO S 350 Laser Scanner (Serial Number LLS081710750). The two sets of scans were conducted on August 3, 2018. INVF, NPS SA (b)(6)(7)(a)(e), and USFS LEO (b)(6), (b)(7)(C) assisted during the scans.

I processed and registered the scans using the FARO SCENE 7.1 Software. I rendered fly through 3-Dimensional (3D) videos and FARO "Scene2Go" end user 3D viewing packages using FARO SCENE 7.1. Electronic copies of the end products and the original scans were provided to the NPS ISB with this supplemental report. END REPORT
