Student Project: Filming for a Talent Show Called “(b) (6)” Games will be the main activity for filming.

Group Size: 25

Activity Date: March 25, 2018 8:30 am – 7:30 pm
Rain Date: March 24, 2018 8:30 am - 7:30 pm

Equipment to be used : Cameras and tripods, small boxes, (2) two tables, (2) two bikes, and jumping ropes, small cones (20 cm tall).

The scope of the filming activity (or production or recording of commercial still pictures) and the manner and extent production will involve the use of parkland are as follows: *(Use additional sheets if necessary.)*

- A. All equipment must be portable and self contained with all stands using rubber tips or matting as a base. All cables must be covered so as not to present a tripping hazard. All equipment must be hand carried / hand carted to event site.**
- B. Filming/photography cannot interfere with public visitation nor other permitted activities. All areas must remain open to the public at all times. No disruption nor impediment of visitor/pedestrian traffic flow allowed. Sidewalks and roadways cannot be blocked at any given time.**
- C. All vehicles must park in designated, available public spaces. Any equipment must be unloaded/loaded from the street curb.**

- D. Particular attention must be paid to protecting the resources. Permittee is responsible for reimbursing the National Park Service for any resource damage much may be incurred as a result of this permitted activity.**
- E. A copy of this permit must be carried at all times by the permittee while operating under the authority granted.**
- F. The National Park Service reserves the right to immediately revoke this permit at any time should it reasonably appear that the filming activity present a clear and present danger to the public safety, good order or health, or if any conditions of this permit are violated.**
- G. Permittee and all participants authorized therein must comply with all of the conditions of this permit and with all reasonable directions of the United States Park Police and/or the National Park Service duty Ranger.**

Weather conditions permitting, work will commence approximately **8:30 am, Sunday, March 25, 2018** and will be completed on **Sunday 25, 2018 by 7:30 pm.** Extension of this permit may only be made by the Superintendent in writing.

(3) The undersigned accepts and will comply with the following conditions:

- (i) Utmost care will be exercised to see that no natural, historic or cultural features are injured, and after completion of the work the area will, as required by the official in charge, either be cleaned up and restored to its prior conditions or left, after clean-up, in a conditions satisfactory to official in charge.
- (ii) Will credit be given to the Department of the Interior and the National Park Service through the use of an appropriate title or announcement (yes or no): **No**
- (iii) Photographing or filming of resident wildlife will be permitted only when such wildlife will not be molested, harmed, or disturbed thereby. Wildlife captured elsewhere will not be allowed in any filming whether trained or not. Domestic animals may be used if humane treatment is maintained at all times.
- (iv) Any special instructions received from the official in charge of the area will be complied with.
- (v) Any additional information relating to the privilege applied for by this application will be furnished upon request of the official in charge.
- (vi) No employee of the National Park Service may work for the permittee in any capacity whatsoever while in uniform or if directly involved in supervision of the permittee.

(vii) No personal gratuity of any nature will be offered to any employee of the Government in connection with the exercise of the privilege granted.

(4) A member of the park staff will supervise the filming done within park boundaries. He/she will have the authority to make all supervisory decisions compliance with the permit, applicable regulations, and Park Service filming policy. **ANY OVERTIME EXPENSE INCURRED DUE TO THE NECESSITY FOR SUCH SUPERVISION WILL BE BORNE BY THE PERMITTEE.**

(5) The permittee will be required to post a bond or cash deposit to insure that the area is left in as good condition after completion of filming activities as it was before. The bond or deposit will be determined by the Superintendent and will be an amount equal to the estimated cost to the Government of clean-up or restoration operations that would occur in the event that the permittee causes damage to resources of facilities or fails to satisfactorily clean up the area. Return of the bond or deposit is subject to compliance with the terms of this permit.

(6) The permittee, in exercising the privileges granted by this permit, shall comply with the regulations of the Department of the Interior, the National Park Service, and all Federal, State, county, and municipal laws, ordinances, or regulations which are applicable to the area of operations covered by this permit.

(7) The permittee is a revocable permit and may be revoked in the discretion of the Director of the National Park Service or his designee upon 24 hours notice, or without notice if damage to resources or facilities is threatened, notwithstanding any other term or condition of the permit to the contrary.

(8) The permittee hereby agrees to save and hold harmless the United States of America, its agents and employees, from any and all claims, damages, suits at law or equity of whatsoever kind of nature for damages to or loss of property or injury or death to persons resulting directly or indirectly from or attributable to the permittee or its employee in connection with the filming activities authorized by this permit. In addition, the permittee agrees to carry a general liability insurance policy in the amount of \$ N/A in which the United States is named an additional insured.

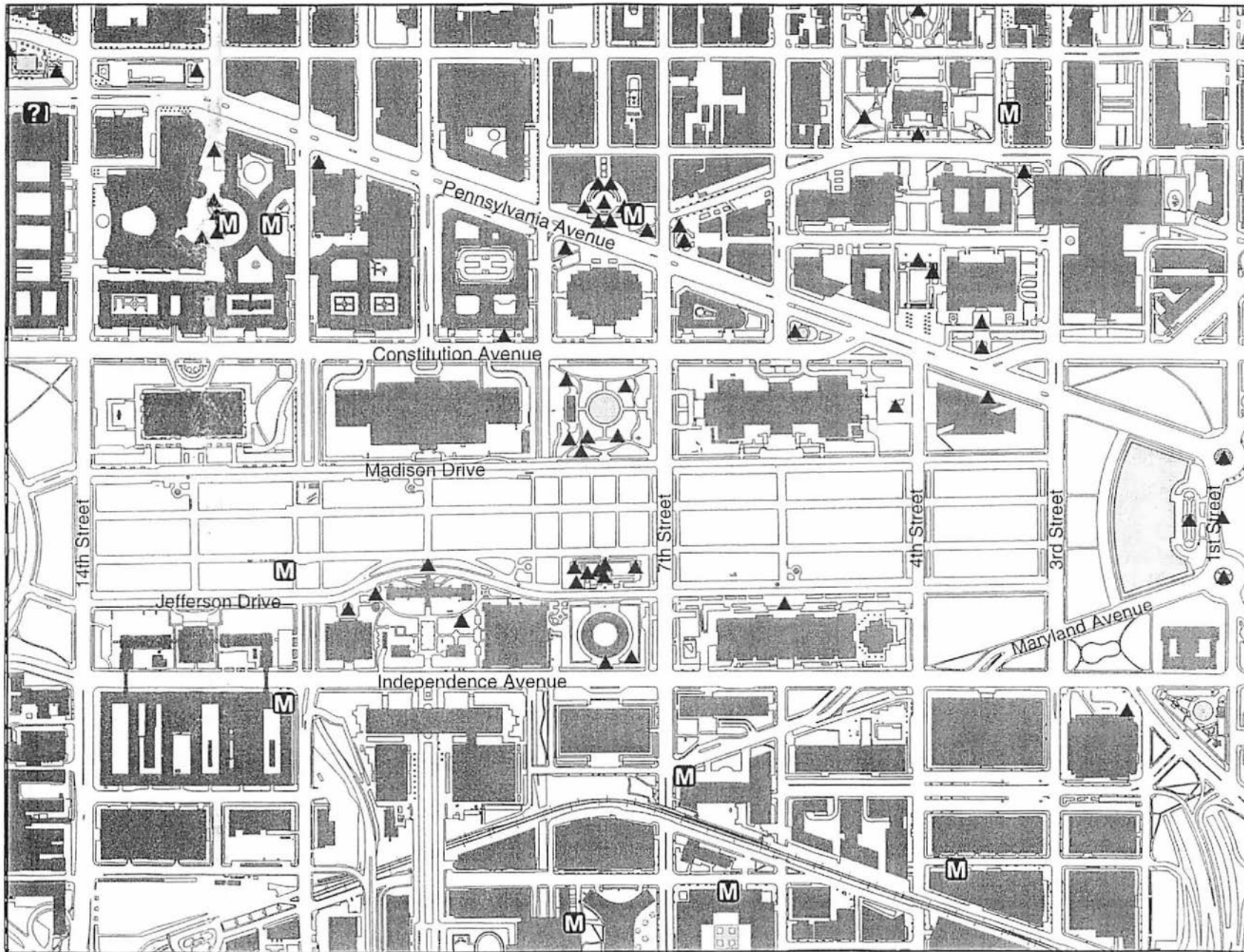

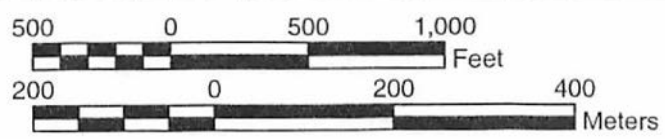
