



Commercial Use Authorization – Vehicle and Vessel Registration Form

Instructions:

1. Print the company name, CUA number(s), phone number, and mailing address, and read and sign the affidavit below.
2. Check the appropriate box to identify the information provided applies to a vehicle or vessel.
3. Enter the required information as it pertains to the vehicle or vessel being registered in the spaces provided below. All information is required. (Form is continued on reverse).
4. **Register only one vehicle or one vessel in each entry. Vessel refers to a motorized vessel.**
5. Registration with the National Park Service (NPS) of all vehicles/vessels used to provide services under this Permit is required.
6. All vehicles/vessels used to provide services under this Permit must be registered or legitimately leased to the Permittee or registered or legitimately leased in the business name.
7. **Registering Additional Vehicles and/or Vessels** (after original submission): Submit this form following the instructions above.

Affidavit: I CERTIFY that I am an agent for the business indicated above. I am authorized to register the vehicles and/or vessels listed in this application. I understand and will comply with the following: (a) Vehicles/vessels not registered with the NPS are not authorized to provide services under this Permit anywhere within the national lakeshore; (b) Signage on all commercially permitted vehicles/vessels will comply with Section 31 of the Provisions of this Permit [Attachment A]; (c) Commercially registered vehicles will not carry visitors for hire into and/or within the national lakeshore unless proof of Public Livery Liability insurance is on record with the NPS and all visitors will pay the applicable Recreation Entrance and Use Fees; and (d) All persons using commercially permitted vehicles for recreation entry into the national lakeshore will pay the applicable Recreation Entrance and Use Fees.
