## This information is only for those permit holders who wish to require clients to sign Acknowledgment of Risk Forms.

## <u>NPS policy states that Commercial Use Authorization (CUA) or Special Use Permit (SUP)</u> holders cannot require visitors (clients) to waive their right to hold them responsible for actions.

<u>"Waivers of Liability" will not be accepted</u>, and the use of such documents will disqualify operators from acquiring a permit. Additionally, the use of any such waivers will immediately render any previously issued permits null and void.

- 1. The Holder is not permitted to require clients to sign a waiver of liability statement or form, insurance disclaimer and/or indemnification agreement.
- 2. The Holder is permitted to request or require clients to sign an acknowledgment of risk statement or form prior to participation.
- 3. The Holder may require or request a client sign a form or statement indicating that the client has certain prerequisite skills that may be required to participate in the commercial activity.
- 4. If the Holder uses an acknowledgment of risk form, a current copy of the form must be sent to the Commercial Services Office for written approval prior to issuance of the CUA or SUP. A CUA or SUP will not be approved if the Acknowledgment of Risk for is not approved by the park.

You may use this form to add your information in the appropriate spaces, however, <u>do not change the</u> <u>document text</u>, as this will delay the approval of your permit while the form is reviewed. The use of any other Acknowledgment of Risk will require review and approval from the Office of the Regional Solicitor and <u>may experience significant delay</u>.

## Visitor Acknowledgment of Risk

The following describes some, but not all, of those risks.

has been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards, and dangers associated with this activity.

I certify that I am fully capable of participating in this activity. Therefore, I assume and accept full responsibility for myself, including all minor children in my care, custody, and control, for bodily injury, death, or loss of personal property and expenses as a result of those inherent risks and dangers identified herein and those inherent risks and dangers not specifically identified, and as a result of my negligence in participating in this activity.

I have carefully read, clearly understood, and accepted the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon me, my heirs, assigns, personal representative, and estate and for all members of my family, including minor children.
