Boston Harbor Islands Advisory Council Meeting Minutes New England Aquarium Central Wharf, Boston June 4, 2003, 4:00 PM – 6:00 PM

Greg Ketchen, Chair, welcomed all. There was not a quorum present (see attached attendance sheet). The approval of the March meeting minutes was tabled.

Nominations

The group discussed the nomination process. There were still some seats that have not been filled. Interest groups should contact Greg Ketchen with the nominations as soon as possible so that the election process can move forward.

Greg Ketchen reminded all that in March 2004, almost half the council seats will be open (instead of the usual 7 seats). The bylaws state that members can not serve more then 2 consecutive 3-year terms. Members that started the council with a 3-year term in March 1998, then served another 3-year term starting in March 2001, will be required to step down for a year before they will be eligible for a council seat again. During this year, members may stay active in the council as an ex-officio. They would be eligible for re-nomination in March 2005. Contact Greg Ketchen or George Price with any questions about this process.

Sam Sapiel stated that he thought the Native American interest group should be separate, and seats should not expire.

Community Outreach Program

Greg Ketchen said that the community outreach project is moving forward. During the process, it was identified that creating new programs was a priority. Jennifer Whitman listed some of the ideas that were generated. The council discussed many ideas for programs.

There was a great deal of interest in creating a PowerPoint presentation that could be used by members to promote the park in their community.

The group also discussed the importance of engaging and educating legislators and key policy makers.

Sam Sapiel expressed concern about Native American burial grounds being protected and about dogs being allowed on Deer Island.

Greg asked each of the interest groups to focus on an area of the plan:

Municipalities - legislative
Business and Commercial - presentations, retreats
Education – local legislators, promoting youth organizations, developing nature and history tours, presentations, write articles for newsletters
Native American – local legislators, history tours
Environmental – no members present
Advocacy – nature guided tours, signage, make contacts
Community – presentations, community involvement

Park Update

George Price, National Park Service, reported that the season has started. The state agencies are working through the budget issues and through the transition into one combined agency to manage the islands. We expect that all 6 state islands will be open for visitors this year. Spectacle Island visitor center is under construction, expected opening is 2004.
