# Park Updates

#### Spectacle Island

Susan Kane reported that DCR was working with the City of Boston and Boston Harbor Island Alliance to open Spectacle Island on Saturday, May 23. Trails look good, visitor center is ready, a generator is in place for electric service, and drinking water will be available on island.

#### Opening Day

The park kicked off the season with a free ferry day on opening day, May 9. It was the largest opening day to date with over 2800 visitors on Georges Island.

#### Dock Assessment

NPS has funding for a dock assessment of DCR public docks that should be complete by the end of 2015. Samantha said that DCR is drafting new capital plans and this assessment will help inform the effort.

# Deer Island

Fred Laskey said that a new public fishing pier at Deer Island was approved at the April Board of Director's meeting to increase public accessibility. Extra parking spots will be added. Salt water fishing licenses are required. Fred reported that the Volunteers and Friends of the Boston Harbor Islands held their annual meeting at Deer Island.

Susan Kane thanked MWRA for their help in water quality testing of the beaches on Spectacle and Peddocks Island.

# Programming

## Summer Programs

Rebecca Smerling, BHIA, gave a report on the programming that is planned for the season that will go into high-gear on June 20. She passed out a calendar of events. One highlight will be an art initiative that will include 10 installations on Georges Island, performance art on Spectacle Island, and landside attractions. Boston Light Tours will resume this year.

# Website

## MET grant
