

This is an application *only* and does not serve as permission to conduct any special activity in the park. The information provided will be used to determine whether a permit will be issued. Send the completed application along with the application fee in the form of a credit card payment to Pay.gov using the following instructions:

Applicants will submit payments via Pay.gov only. Credit cards are preferred. Do not send checks.

- 1. Enter "CANY" or "ARCH" in the Pay.gov search window.
- 2. Payment will be made at: Canyonlands and Arches NP & Natural Bridges and Hovenweep NM Special Use Permit click "Continue"
- 3. Fill in all boxes with the required information.

- 4. Do not enter a permit number (not applicable).
- 5. Enter a total dollar amount of \$185 for the permit application fee.
- 6. Follow prompts on each page to complete the payment.
- 7. Save your payment confirmation as a PDF document; you will submit this with your application.

If your request is approved, a permit containing applicable terms and conditions will be sent you. The permit must be signed by the responsible person and returned to the park for final approval by the Park Superintendent before the permitted activity may begin.

### **Privacy Act Statement**

Authority: The authority to collect information on the attached form is derived from 54 U.S.C. 100101.

**Purpose:** The purposes of the system are (1) to provide a park superintendent with information to approve or deny requests for activities that provide a benefit to an individual, group or organization, rather than the public at large; and (2) to assist park staff to manage the activity to ensure that the permitted activity does not interfere with the enjoyment of the park by visitors and that the natural and cultural resources of the park are protected.
