

# The Great Wright Brothers Aero Carnival Photo Contest

## September 27, 2014

Three age categories

7 – 15 years old      16 years old and Over

Categories for photos

Aircraft (modern or historic), aviation facilities (airports, hangars, etc.), and events (Like the Dayton Air Show)

Aviation Trail sites or National Aviation Heritage Alliance sites. This includes buildings at the sites, monuments and site related events. Locations can be found on the Aviation Trail and National Aviation Heritage Alliance web sites.

Photos must be original work taken at sites and/or aviation activities within Auglaize, Champaign, Clark, Greene, Miami, Montgomery, Shelby or Warren Counties, Ohio that make up the National Aviation Heritage area.

Photos must have been taken during between 2010 and July 15, 2014. Photos previously submitted to this contest are not eligible for consideration.

Photos must be aviation related. Finalist entries will be placed on exhibit in some form during and immediately after the event. This could include web sites, newsletters, press releases and exhibitions.

Participation is limited to a total of two entries per category per photographer for a total of four photos.

Any image depicting individuals will need to be accompanied by a signed photo release. A release form can be found as a separate page in this section. Photos depicting crowds do not require photo releases. \*Any images that might be used for commercial profit that are taken on United States government property are subject to the restrictions outlined in the Code of Federal Regulations 43 CFR 5.1 and Public Law 106-206.

Photos must be submitted via email to [Gregg\\_Smith@nps.gov](mailto:Gregg_Smith@nps.gov) only no later than July 15, 2014. Images will be added to the web site at least once a week. Winning entries will be featured on the park web site [www.nps.gov/daav](http://www.nps.gov/daav) shortly after Sunday, September 28.

All images must be submitted in either JPG, PNG, or TIFF formats with a file size that does not exceed 25 megabits. Resolution of photographs should not exceed 1024 x 768 dpi. The use of PhotoShop or other graphics programs is permitted but that usage must be acknowledged on the entry form. The entry form must be printed out, filled out and sent to Dayton Aviation Heritage NHP, 16 South Williams Street, Dayton, Ohio 45402 attn: Gregg Smith. Please use your name and title of the photo in your saved jpeg, tiff, png, file.

The 1<sup>st</sup>, 2<sup>nd</sup>, and honorable mention entries will be printed and mounted by Dayton Aviation Heritage National Historical Park. The winners will be announced at the Aero Carnival on Saturday, September 27, 2014 at 1:30 pm. Photographers may be asked to provide their entries in a higher dpi format for printing.

Dayton Aviation Heritage National Historical Park, Aviation Trail, Inc., and the National Aviation Heritage Alliance will retain the right to use the 1<sup>st</sup>, 2<sup>nd</sup>, and honorable mention entries with photo credit in publicity and promotional efforts for a period of three years. At the end of that time, the entries will become the sole property of the photographer unless other specific agreements have been reached with the photographer. The photographer will retain other commercial rights to the images. In addition Dayton Aviation Heritage National Historical Park, Aviation Trail, Inc., and the National Aviation Heritage Alliance retain the right to publically exhibit the 1<sup>st</sup>, 2<sup>nd</sup>, and honorable mention entries for a period of three years after the September 27, 2014 date of the event. This could include exhibits by the National Park Service, Aviation Trail Inc., and the National Aviation Heritage Alliance at sites within the organizations or events sponsored by them. At the end of that period the prints become the property of the photographer who must pick up their printed entries at the park visitor center located at 16 S. Williams Street, Dayton, Ohio. Any images not picked up within six months will become the property of Dayton Aviation Heritage National Historical Park. All non-winners entries will be deleted from the web site by November 30, 2014.

Preliminary judging of large numbers of entries will be conducted by Park Service staff. The final judging of images will be conducted by  
Marvin Christian, Dan Patterson, and Steven Wright

Staff of Dayton Aviation Heritage National Historical Park, the judges, the management staff of the partner organizations and members of their immediate families are not eligible to enter.

Depending on the number of entries per category, prizes will be awarded for 1<sup>st</sup>, 2<sup>nd</sup>, and honorable mention.
