

**FORT MCHENRY NATIONAL MONUMENT AND HISTORIC SHRINE
HAMPTON NATIONAL HISTORIC SITE
SPECIAL USE PERMIT FEES**

The National Park Service is required by Federal Law to recover costs associated with providing necessary services to permittees. The costs will vary depending on the size and scope of the proposed activity. **A \$100.00 non-refundable application fee is charged for each permit application submitted to the Park for review. This fee covers the costs associated with reviewing the application and is charged whether or not the request is approved.** All events will require Park employees to monitor and provide support. Costs above normal Park operating costs will be billed to the permittee following the activity. These could include expenses related to security, parking, crowd control, cleanup, and coordination with outside agencies. The National Park Service reserves the right to recover costs of support by Service personnel from before, during, and after an event.

COMMERCIAL USE AUTHORIZATION FEES**

Commercial Use Authorization (CUA) is a permit that authorizes suitable commercial services for park visitors at Fort McHenry and Hampton. CUAs are issued with park specific rules and regulations in order to minimally impact the park area's resources and values and help keep the CUA holder consistent with the purpose for which the park was established. CUAs include commercial tours, advertising Fort McHenry and/or Hampton, commercial buses, and food vendors. **Each year an administrative fee is required for issuance of a CUA, which is \$50.** All CUAs are issued for an entire year.

After approval the fee to conduct business for the year is \$150.

A Certificate of Liability Insurance is required. It must be for at least \$1,000,000, the "United States of America" must be listed as the additionally insured, and the certificate holder is as follows:
