HISTORY

Fort Stanwix National Monument (FOST) was established under the Wagner-Sisson Act (49 Stat. 665), which President Franklin D. Roosevelt signed on August 21, 1935. At first, however, this designation as a National Monument did little more than recognize the existence of a potential archeological site at what was believed to have been the location of the 18th and early 19th century facility. The fort itself, however, had been razed many decades earlier, and the area where it once stood given over to commercial development in downtown Rome, New York.

It was not until the mid-1960s that the National Park Service (NPS) initiated plans to reconstruct the fort with the intention, in the words of the park's General Management Plan, of preserving "the location, resources, and stories associated with the military, political, and cultural events that occurred at the site of Fort Stanwix and [providing] opportunities for visitor understanding and appreciation of these events." The City of Rome had approached the NPS at that time for advice about developing the fort as part of a planned urban renewal project. In response to the city's request, the NPS completed a master plan in 1967 outlining the reconstruction project. Following the clearance of existing buildings and streets from a fifteen-acre site surrounding the original fort and a period of archeological excavations and historical research lasting from 1970 to 1973, a groundbreaking ceremony launching the reconstruction of Fort Stanwix occurred on August 23rd, 1974, and the NPS celebrated the grand opening of the partially-completed facility on May 22, 1976, in conjunction with the many national observances held that year to commemorate the Bicentennial of the United States.

Fort Stanwix was originally constructed by the British in 1758 to protect the strategic portage between Wood Creek and the Mohawk River, an important east-west transportation route. During the Revolutionary War, American forces occupied the fort and successfully repulsed a siege conducted by British forces under the command of Brigadier General Barry St. Leger. The British attack was the western theatre of a planned three part invasion of New York. British forces were to move south from Canada through Lake Champlain, north from New York City up the Hudson River, and west through the Mohawk River Valley, eventually to meet at Albany, NY. The failed siege, and the Battle of Oriskany on August 6th, 1777, forced St. Leger to retreat, a reversal for the British that culminated in the surrender of a second British army commanded by General John Burgoyne at Saratoga in October, 1777. The British defeat helped to win the French and European allies for the United States.

Fort Stanwix's strategic location made it an important site in the contest of nations, both European and American Indian (Six Nations), for control of the Mohawk Valley and access to the Great Lakes and the interior of North America. Seven treaties with the Iroquois and other American Indians concerning boundaries and land transfers are associated with Fort Stanwix. Controversies arose between the American Indians and representatives from the federal and state governments who negotiated and renegotiated the treaties to benefit American expansionists. The legacy of these treaties continues in contemporary legislative policy, land claims, and American Indian relations. In the years following the Revolutionary War, the City of Rome, New York, grew up around the abandoned ruins of Fort Stanwix, eventually erasing visible evidence of the fort.

Fort Stanwix was designated a National Historic Landmark in 1962 and the site is listed in the National Register of Historic Places. The reconstruction of Fort Stanwix (1974-1978) was built on the site of the original fort, based on historic documentation, archeological excavations, and historic architecture studies. The reconstructed fort was built to resemble the fort circa 1777-1778 and maintains one original feature, a brick foundation to a hearth. Archeological excavations conducted prior to the reconstruction resulted in a collection of 18th century artifacts associated with the fort and a collection of 19th and 20th century artifacts from subsequent occupation of the site. The current collection is comprised of approximately 450,000 archeology specimens, with 45,000 objects linked to the 18th century period of primary significance.

Visitors to Fort Stanwix National Monument are engaged through interpretive programs, museum exhibits, films, special events, and re-enactments. The interpretive program is designed to provide understanding to visitors about the significance of the military events that took place at the site during the American Revolution and the role the fort played in the relations between the British, French, Americans, and American Indians during the 18th century.

A 2001 National Park Service study of Oriskany Battlefield State Historic Site resulted in a cooperative partnership with the New York State Office of Parks, Recreation, and Historic Places to share resources in interpreting the interrelated stories of these historic sites. In 2005, The Marinus Willett Collections Management and Educations Center was opened featuring exhibits, audiovisual presentations, a bookstore, and a climate controlled museum collections storage area. The addition of the Willett Center has enabled FOST to properly protect, store, and preserve the archeological, archival, and historical collections, contributing to an enhanced visitor experience.

SERIES DESCRIPTIONS

I. SERIES I: ADMINISTRATIVE RECORDS, 1967-2012

Organized into four subseries: Subseries A, Central Files; Subseries B, Management and Planning Documents; Subseries C, Superintendent's Office Records; and Subseries D, Reports.

The records document the administrative functions of Fort Stanwix National Monument. There are records detailing the planning of the fort reconstruction (1974-1978), interpretive planning and media, management of the archeological collection, partnerships with civic and interrelated organizations, and the maintenance and preservation of park resources.

A. SUBSERIES A: CENTRAL FILES, 1975-2008

Arranged by alpha-numeric code, as specified in NPS Records Disposition Manual (NPS-19, Appendix B). Records are grouped into the following categories: "A" files: Administration; "C" files: Concessions; "D" files: Development and Maintenance; "F" files: Fiscal; "H" files: History and Archaeology; "K" files: Interpretation and Information; "L" files: Lands and Recreation; "N" files: Natural and Social Sciences; "P" files: Personnel; "S" files: Supplies, Procurement, and Property; "W" files: Laws and Legal Matters; "Y" files: Fire Management.

Permanent coded files created during administrative functions, including correspondence, reports, memoranda, minutes, news releases, organization charts, permits, proposals, inventories, and contracts. This subseries contains correspondence regarding National Park Service initiatives, interpretive programs, and park planning activities. Principle correspondents include: the park superintendent, division chiefs, The Northeast Regional Office, regional directors, Harper's Ferry Center, and the Washington Area Service Office (WASO).

B. SUBSERIES B: MANAGEMENT AND PLANNING DOCUMENTS, 1967-2009

Arranged alphabetically by title and thereunder chronologically.

Reports, plans, maps, drawings, correspondence, spreadsheets, drafts, transcripts, newsletters, handwritten notes, compact discs, and computer disks. The records in this subseries document the planning, design, development, execution, and evaluation of various park projects and initiatives. The reports include: General Management Plan and Environmental Impact Statement, Resource Management Plan, Master Plan,

Administrative History Report, Advanced Design and Cost Study, Business Plan, Comprehensive Design Report, Operations Evaluation, Statements for Management, and Superintendent's Compendium among others. There are several compilations of documents and reports regarding the establishment and development of Fort Stanwix National Monument.

C. SUBSERIES C: SUPERINTENDENT'S OFFICE RECORDS, 1970-2012

Arranged chronologically.

Correspondence, reports, memoranda, news releases, fiscal statements, invoices, spreadsheets, graphs, maps, surveys, organization charts, handwritten notes, computer disks, zip disks, and compact discs. This subseries contains records from the office of the superintendent concerning park management. Subjects include budget formulation, the combined call, project planning, and resource sharing activities amongst members of the Upstate New York Sub-cluster. There is compliance documentation for the Government Performance and Results Act (GPRA) and the Accountability, Continual Improvement, Training (ACT) program. In addition, there are records for natural resources management and related initiatives.

This subseries is described at the file unit level (see File Unit Description).

D. SUBSERIES D: REPORTS, 1973-2007

Arranged alphabetically by title and thereunder chronologically.

Reports, memoranda, and compact discs. Subjects of reports include: City of Rome municipal planning, health and safety issues, trails and recreation, traffic and transportation studies. The reports are authored by the National Park Service, City of Rome, Federal Highway Administration, United States Department of Transportation, architecture and engineering firms, and partnerships with universities.

II. SERIES II: CULTURAL RESOURCES MANAGEMENT RECORDS, 1923-2008

Organized into twelve subseries: Subseries A: Administrative History; Subseries B, American Battlefield Protection Program; Subseries C, Archeological Records; Subseries D, Collections Management Records; Subseries E, Cultural Landscapes Inventory; Subseries F, Ethnography Projects; Subseries G, Historic Sites/Structures/Furnishing Records; Subseries H, Native American Graves Protection and Repatriation Act; Subseries I, Newspaper and Press Clippings; Subseries J, Partnerships; Subseries K, Still Images; and Subseries L, Subject Files. This series contains records created by the park's cultural resources management division. Included are records for the management, preservation, and protection of the archeological collection as well as various initiatives and special studies undertaken to preserve the stories of the military, political, and cultural events that occurred at the site of Fort Stanwix.

All subseries and sub-subseries are described at the file unit level (see File Unit Description) with the exception of Subseries I, Newspaper and Press Clippings.

A. SUBSERIES A: ADMINISTRATIVE HISTORY, 1923-2008

Organized into two sub-subseries: Sub-subseries 1, Project Files; and Sub-subseries 2, Research and Background Files.

This subseries contains records created during the writing of "Reconstructing the Past, Partnering for the Future: An Administrative History of Fort Stanwix National Monument," by Joan M. Zenzen. The administrative history was created to inform park managers, park service personnel, and interested readers about the origin and evolution of Fort Stanwix National Monument.

1. SUB-SUBSERIES 1: PROJECT FILES, 1986-2008

Arranged chronologically.

Correspondence, memoranda, reports, news clippings, drafts, contracts, invoices, release agreements, transcripts, audio cassettes, computer disks, and compact discs. The records document the management, planning, research, editing, and commentary created during the project. There are oral history interviews of park personnel and others involved in park planning, interpretation, and visitor services. These interviews are recorded on audio cassettes and transcribed.

2. SUB-SUBSERIES 2: RESEARCH AND BACKGROUND FILES, 1923-2007

Arranged alphabetically.

Reports, memoranda, news clippings, legislation, and compact discs. The records are the compiled research efforts that author Zenzen created in order to write the administrative history. In most cases park reports, planning documents, memoranda, and newspaper clippings are photocopies.

B. SUBSERIES B: AMERICAN BATTLEFIELD PROTECTION PROGRAM (ABPP), 1990-2005

Arranged alphabetically by subject and thereunder chronologically.

Surveys, correspondence, reports, monographs, bibliographies, news releases, logs, drafts, memoranda of agreement, maps, photographs, computer disks, zip disk, and compact discs. The American Battlefield Protection Program (ABPP) is a National Park Service program designed to identify, document, and map American battlefields. The goal of the battlefield survey program is to collect baseline information on the location's condition and identify threats to the landscape and its component resources for purposes of education and preservation. This subseries includes battlefield surveys for Fort Stanwix and associated historic properties, Oneida Castle, and Oriskany.

C. SUBSERIES C: ARCHEOLOGICAL RECORDS, 1965-2008

Organized into in two sub-subseries: Sub-subseries 1, Administrative Records; and Sub-subseries 2, Project Records.

This series contains records on the management, preservation, and protection of the Fort Stanwix archeological collection. Archeological excavations conducted during the 1960s and early 1970s uncovered the main features of the fort, along with many 19th and 20th century features associated with buildings that had been constructed over the ruins. The collections, including archives, number approximately 450,000 items pertaining to both the 18th century fort occupation (1758-1781) and the 19th and 20th century City of Rome, NY (1796-1970).

1. SUB-SUBSERIES 1: ADMINISTRATIVE RECORDS, 1971-2008

Arranged chronologically.

Correspondence, memoranda, reports, handwritten notes, monographs, permits, spreadsheets, organization charts, news clippings, maps, drawings, and computer disks. This subseries includes records on the permit process, research findings and notes, inventories, compliance and regulations, and reports on the collection.

2. SUB-SUBSERIES 2: PROJECT RECORDS, 1965-2008

Arranged chronologically.

Memoranda, reports, correspondence, field notes, maps, drawings, architectural plans, inventories, news clippings, photographs, slides, negatives, and computer disks. This subseries contains records created in conjunction with archeological excavations, cataloging projects, and documentation of the collection. Included is the report "Casements and Cannonballs: Archeological Investigations at Fort Stanwix National Monument," which details the military archeology of the fort.

D. SUBSERIES D: COLLECTIONS MANAGEMENT RECORDS, 1963-2008

Organized into three sub-subseries: Sub-subseries 1, Administrative Records; Subsubseries 2, Plans and Reports; and Sub-subseries 3, Project Records.

This subseries contains records related to the Fort Stanwix National Monument museum collection of approximately 485,000 artifacts and historic archival items. With the reconstructed fort, the museum collection is preserved to tell the story of events that transpired at and around the site during the Colonial Period and the American Revolutionary War. Of the total collection, approximately 45,000 artifacts have been recovered from the period of primary significance for the park. The collection is stored, and portions are displayed, in The Marinus Willett Collections Management and Education Center.

1. SUB-SUBSERIES 1: ADMINISTRATIVE RECORDS, 1963-2008

Arranged chronologically.

Correspondence, memoranda, handwritten notes, reports, monographs, logs, inventories, invoices, news clippings, photographs, computer disks, and compact discs. This sub-subseries contains records on artifacts, environmental controls and monitoring, exhibits, conservation, research subjects, and logs recording collection related events.

2. SUB-SUBSERIES 2: PLANS AND REPORTS, 1983-2008

Arranged chronologically.

Reports, surveys, memoranda, drafts, correspondence, handwritten notes, spreadsheets, architectural plans, and computer disks. This sub-subseries contains collection condition surveys; collection management plans; collections management reports; Museum Collection and Exhibit Housekeeping and Preservation Plan; Museum Collection Curatorial Facility Plan; Museum Collections Emergency Operations Plan; Scope of Collection Statement; and Summary Reports: Park Collections Management Program among others.

3. SUB-SUBSERIES 3: PROJECT RECORDS, 1979-2008

Arranged alphabetically by project name and thereunder chronologically.

Correspondence, memoranda, contracts, invoices, spreadsheets, reports, drawings, floor plans, handwritten notes, and compact discs. This sub-subseries contains records for Archival Records Typing Project, Artifact Labeling Project, cataloging projects, Collection Management Project, Collections Stabilization Project, Cultural Resources Bibliography, exhibit rehabilitation, Hearth Exhibit, and Technical Assistance Project to rehouse portions of the archeological collection.

E. SUBSERIES E: CULTURAL LANDSCAPES INVENTORY, 1993-2006

Arranged chronologically.

Reports, memoranda, correspondence, cooperative management agreements, project agreements, maps, drafts, photographs, slides, computer disks, zip disks, and compact discs. The Cultural Landscapes Inventory is a comprehensive inventory of all culturally and historically significant landscapes within the National Park System. The inventory documents the location, description, condition, historical development, and current management of the landscape based on criteria established by the National Register of Historic Places. Included are Cultural Landscape Inventories for Fort Stanwix (1993, 2000) and a Cultural Landscape Report for Oriskany Battlefield, a New York State Historic Site partnered with the National Park Service through a cooperative management agreement.

F. SUBSERIES F: ETHNOGRAPHY PROJECTS, 1988-2007

Arranged alphabetically by project title and thereunder chronologically.

Correspondence, reports, contracts, news clippings, maps, drafts, handwritten notes, news releases, computer disks, and zip disks. The National Park Service conducts ethnographic research on contemporary American Indians and other peoples with traditional ties to specific park units in order to develop and implement culturally appropriate resources management strategies. This subseries includes two reports by author Joy A. Bilharz on Mohawk Valley Battlefield Ethnography: "A Place of Great Sadness," (1998) and "The 'Western Indians' and Mississaugus," (2002). In addition, there are records on Section 106 compliance, Native American legal issues, background on the National Park Service Ethnography Program, and military re-enactments.

G. SUBSERIES G: HISTORIC SITES/STRUCTURES/FURNISHINGS RECORDS, 1962-2006

Arranged alphabetically by subject and thereunder chronologically.

Reports, drawings, memoranda, correspondence, drafts, news clippings, and maps. This subseries contains the reports: "A Furnishing Plan for the Reconstruction of Fort Stanwix

at the Oneida Carrying Place, New York," "Fort Stanwix History, Historic Furnishing, and Historic Structure Report," "Historic Furnishing Study," "Historic Structure Report, Architectural Data Section on the Reconstruction of Fort Stanwix (Part I and II)," "History of a Nineteenth Century Urban Complex on the Site of Fort Stanwix, Selections from the Historic American Buildings Survey," and "The Construction and Military History of Fort Stanwix." There are National Register of Historic Places nomination forms for Fort Stanwix, Oriskany Battlefield, and Rome, New York area historic buildings. In addition, there are National Survey of Historic Sites and Buildings forms for Fort Stanwix and Oriskany Battlefield. There are also records on the List of Classified Structures and the National Historic Landmarks Program, including a photocopy compilation of memoranda and correspondence on the establishment and development of Fort Stanwix.

H. SUBSERIES H: NATIVE AMERICAN GRAVES PROTECTION AND REPATRIATION ACT (NAGPRA), 1975-2005

Arranged chronologically.

Correspondence, reports, legislation, news releases, news clippings, handwritten notes, and computer disks. This subseries contains records on compliance for the Native American Graves Protection and Repatriation Act, including a "Protocol between Fort Stanwix National Monument and the Oneida Indian Nation," regarding funerary objects found during archeological investigations.

I. SUBSERIES I: NEWSPAPER AND PRESS CLIPPINGS, 1927-2004

Arranged chronologically.

This series contains newspaper clippings collected by park personnel, including Superintendent Mike Caldwell, and a news clipping service. In addition to individual articles the records include special sections and issues, such as the Daily Sentinel, Bicentennial Issue. The newspapers include: Daily Sentinel (Rome), The Observer-Dispatch (Utica), The Daily Press (Utica), The Syracuse Herald-Journal, The Post Standard (Syracuse), The Syracuse Herald American, The Times Union (Albany), Buffalo News, and the New York Times. Among the subjects collected are articles on: Fort Stanwix National Monument, National Park Service, special events and holidays, The Erie Canal National Heritage Corridor, Erie Canal Village, Oriskany Battlefield State Historic Park, The Marinus Willett Collections Management and Education Center, Oneida Indian Nation, Iroquois Indians, Griffiss Air Force Base and Rome Laboratory, The Rome Historical Society, local economy, Rome area businesses, tourism, Rome area development, Department of Housing and Urban Development, New York State historic sites, National Register of Historic Places, Niagara Falls National Heritage Area, trails, and editorials.

J. SUBSERIES J: PARTNERSHIPS, 1962-2008

Arranged alphabetically by institution/organization and thereunder chronologically.

Correspondence, memoranda, reports, legislation, cooperative agreements, brochures, news releases, news clippings, maps, handwritten notes, drafts, transcripts, photographs, computer disks, and compact discs. This subseries contains records on organizations and institutions which share resources, goals, and common interests with Fort Stanwix National Monument and the National Park Service. The partners, both formal and informal, include: Canal Corridor Initiative, The Erie Canal National Heritage Corridor and the New York State Canal System, Mohawk Valley Heritage Corridor, the Oneida Indian Nation, Oriskany Battlefield State Historic Park, Revolutionary War historic sites, The Northern Frontier Project and special resource study, and The Underground Railroad unit of the National Park Service.

Arranged alphabetically by subject.

Photographs, slides, negatives, invoices, handwritten notes, an audio cassette, and compact discs. This subseries contains visual records of the reconstructed fort, park grounds, park buildings and surrounding structures, interpretive programs, living history program, reenactments, educational presentations, special events, museum exhibits, construction and maintenance projects, archeological excavations, visitors, volunteers, and park employees.

L. SUBSERIES L: SUBJECT FILES, 1964-2007

This subseries contains records related to the management of Fort Stanwix's cultural resources and to the stories associated with the military, political, and cultural events that occurred at the site. The records include historical chronologies; historical maps; historical reference and research materials; background information on historic objects and artifacts; historic and current research on events, issues, and relationships with the Iroquois Indians and related Indian tribes; and federal, state, and local historical initiatives.

This series contains records created during the reconstruction of Fort Stanwix National Monument and its continued maintenance and upkeep by the park's Facilities and Maintenance Division. This subseries includes records on the reconstruction of the fort, redesign of the maintenance facility, rehabilitation projects, roadwork, sidewalks, and trails. There are the National Park Service project reports, "The Reconstruction of Fort Stanwix, Specifications (Phase I and II)." In addition, the reconstruction records include documentation on timbers, concrete, landscaping, nursery stock, environmental controls, electrical, plumbing, doors, windows, roofing, fixtures, fire prevention, safety features, parking, roads, security, hardware, and phones. There are construction, planning, development, and design records with the general contractor, B.S. McCarey Company; architects/engineers, Duryea and Wilhelmi; architects/engineers, Day & Zimmerman Associates; mechanical constructors, O'Shea Associates; and various subcontractors. The records include daily contractor diaries, concrete test reports, soil test reports, change orders, invoices, and completion reports.

V. SERIES V: WILLETT CENTER DESIGN AND CONSTRUCTION RECORDS, 1993-2008

Organized into 4 subseries: Subseries A, Administrative Records; Subseries B, Cultural Resources Management Records; Subseries C, Interpretation/Exhibit Planning and Design; and Subseries D, Design and Construction Records.

The records pertain to the management, planning, design, and construction of the Marinus Willett Collections Management and Education Center. Included are records of

archeological investigations, compliance documents, environmental assessments, financial planning, site surveys, collections management requirements, museum design, interpretive exhibits, architectural plans, and construction specifications.

0013. ORAL HISTORY, RECORDINGS, RELEASES, TRANSCRIPTS, 2003-2004
