## **BUILDING 600 OWNERSHIP**

NPS Recognition of building ownership states: "...there do seem to be discrepancies between some of the county and state's information and that of NPS."

The 1980 U.S. Army Corps of Engineers Easement Survey was sent to me by Shawn Welch after our last FACA Meeting when he sourced the document online while we spoke. Supt. Nersesian stated in her letter, "We have not been able to identify any easements that exist on the property." This easement raises some questions relating to the hash marks which cover the ocean side of the property and not the river side where the house is located. The area without hash marks matches the 1974 Sandy Hook Deed transfer which gives part of this parcel to NJDOT. We would like to pursue clarification as soon as possible due to the imminent need of a roof repair.

To Whom It May Concern:

I am writing on behalf of the Sandlass Home of Sandy Hook to request that you work with the advocates to find a resolution in bringing the Sandlass Home back to its former glory.

This home is a pivotal component of New Jersey's historical makeup. It is the last remaining part of the Highland Beach Resort, drawing a crowd of 15,000 people a day during the summer for special leisurely family vacations. It was one of the carliest Jersey Shore destinations from the 1800s, and uniquely positioned at the beginning South End of the Sandy Hook peninsula. The home has remained an incredible source of history and was influential in making the Jersey Shore the popular tourist destination it remains todar.

While I understand that the home was moved from its original location in 1940, the historic importance of the site has not altered, and the original structure still remains intent to this day. Even through the catastrophe of hurricane Sandy, the house remained undamaged due to its pristine location and protection from the bridge abutment per the NIDOT design. A local entrepreneur Brian Samuelson, the first and current lessee to save a building in the Landmark, has stepped forward to facilitate an urgently-needed roof repair with a wish to refurbish the home into an Airbha giving it access to future generations visiting Sandy Hook.

The acceptance of the NJDOT research validating Sandlass Home 600's historical importance on the Sandy Hook peninsula currently exhibited at NJ State Park's Navesink Light Station Historic Landmark.

- We request a quick solution to the question of ownership in the 1980 U.S. Army Corps of Engineers Easement Survey, and discrepancies in the county and state's information due to the imminent threat of a roof collapse.
- As advocates, a petition last July which garnered over 1,800 signatures to gain permission for this Airbnb concept at the 1893 Sandlass House on Sandy Hook, was delivered to NPS. The community, the legislators and local town councils champion this endeavor to preserve the last remaining remnant of the 1888-1963 Highland Beach Resort at Sandlass Beach.
