SURF-LIFEGUARD TEST DATES / SITES / TIMES

Two sets of dates appear directly below. On the left side are the last possible dates on which you can pass the Surf-Lifeguard Preemployment Test and still be considered for employment or for reemployment at Gateway National Recreation Area in the time periods whose beginning dates are given on the right side. (For example, you must pass all parts of the test in order at any test session on or before March 28, 2010, if you wish to be considered for employment or for reemployment at Gateway National Recreation Area in the time period beginning May 9, 2010.) Note: To be eligible at Gateway National Recreation Area for early consideration, you must pass all parts of the test in order on or before March 28, 2010. You may take the test as often as it is offered.

REMINDER

You must take care of the following matters if you wish to be permitted to take the test. Otherwise, you will not be permitted to take the test:

COMPLETE FORM FOR ADMISSION TO TEST

You must complete the form entitled "Application for Admission / Surf-Lifeguard Preemployment Test." A National Park Service representative will have a copy of this form available for you at the test site. He or she will serve as the witness that is required of your signature on this form.

PROOF OF AGE

Please bring acceptable proof of age with you to the test site (e.g., birth certificate, driver's license, or U.S. passport).

IF UNDER 18 YEARS OF AGE

If you are under 18 years of age on the date of the test, your parent or legal guardian must accompany you to the test site and sign the appropriate section of the form that is entitled "Application for Admission / Surf-Lifeguard Preemployment Test."

NOTE

If your parent or legal guardian cannot accompany you to the test site, we can mail you a copy of this form. Your parent or legal guardian can have his or her signature attested to by a currently certified notary public. To be acceptable, the notary's official stamp or seal must appear on this form, together with the notary's full name, original signature, registration number, and commission-expiration date. Please bring the notarized form with you to the test site.

APPROPRIATE CLOTHING FOR TEST

A swimsuit, sweatshirt, gym shorts or sweatpants, warm cap (for running outdoors in cool weather), running shoes, and towel are examples of what you will need, plus a lock of some sort to secure your valuables.

TEST-SITE PARKING FEE

Please be aware that some of test sites may charge a parking fee. If so, it is your responsibility to pay. The National Park Service has no control over this, and will not reimburse you for that fee.
