Private Vessel Entry Permit Application 2021

Private motorized vessels are required to obtain a permit and orientation prior to entry into Glacier Bay, including Bartlett Cove, June 1st to August 31st. Glacier Bay begins at Point Gustavus across to Point Carolus. Please complete all fields of this form and email to GLBA_VIS@nps.gov within 60 days of your requested entry dates. Applications received earlier than 60 days will be denied. Upon receipt of your application, you will be mailed/emailed a confirmation or response form with further information. Permits may be issued for up to 7 consecutive days, no more than 2 permits may be held at once. Please give three date options for your request. Please print or type. Incomplete or unreadable applications will not be processed.
