



## Weddings



Weddings are permitted in Grand Teton National Park. Entrance fee and permit requirements apply. These are based on the location of the wedding ceremony and the location of the reception.

---

### Permits

A permit is required to hold a wedding in the park except for the locations listed as follows. A fee of \$50 per permit is charged. To obtain a wedding permit application please visit the Grand Teton website,

Permits are not required for weddings held in the Chapel of the Transfiguration, the Chapel of the Sacred Heart, or at a concession facility.

### Entrance Fees

Normal entrance fees are charged for all wedding participants and guests as they pass through a park entrance station. Lump sum or advance payments are not accepted. All guests entering the park to

attend a wedding ceremony at the Chapel of the Transfiguration will not be charged an entrance fee. Because the Chapel of the Transfiguration is on private property within the park, we cannot charge an

entrance fee. However, if these same guests will be attending a reception inside the park, all guests will be charged an entrance fee.

### Special Regulations

No disturbance of vegetation or other natural object is allowed. Park regulations do not permit the throwing or scattering of rice, birdseed or flower petals. Bands, barbecues, sound systems, props, etc, are not allowed unless inside a concessions building and within the scope of

the concessioner's permit or contract. Any event that interferes with the normal activities of the visitor such as the closing of trails, overlooks or public use facilities will not be allowed. Permittee will assume all responsibility for cleanup of the

site. All vehicles for the wedding party and guests must be parked in designated parking areas. Carpooling is recommended; parking may be limited in some areas.

### Winter Road Closures

From about October 31 to mid-May, depending on weather, certain roads are closed to vehicles. These include the

Teton Park Road from Taggart Lake Trailhead to Signal Mountain and the unpaved portion of the Moose-Wilson Road, be-

tween Moose and Teton Village. Other roads may be closed—please check with the Chief Ranger.
