DESCRIPTION

This collection contains paper records, photographic prints, digital images and maps created or used by the Protection Division which includes Law Enforcement and the Eruption crew. Records document park procedure for possible incidents occurring in the park. A majority of the records document operations, plans, staffing and signage in use during eruptions of Kīlauea Volcano. Significant eruptions include the Mother's Day Lava Flow and resulting Kupukupu Fire of 2002-2003 and the additional lava flows of 2005-2010. 1981-2010.

ORGANIZATION

This collection is organized into two series: Series I, Administration and Series II, Eruptions. The creation of additional series is anticipated as records are transferred to the archives from the division.

SERIES DESCRIPTIONS

I. SERIES I: ADMINISTRATION, 1981-1997

The collection of administrative records contains the paper documents created by the Protection Division of Hawai'i Volcanoes National Park from 1981-2010.

Organized into four subseries: Subseries A, Park Plans; Subseries B, Incident Reporting and Procedure; Subseries C, Airspace Management; Subseries D, Hazard Management

Administrative documents which support, direct, and document the actions of the Protection Division staff and other park workers as they manage the eruptive episodes in Hawaii Volcanoes National Park.

Planning, procedures and reporting documents are included as well as protocols for managing airspace concerns, hazardous substances and natural disasters.

A. SUBSERIES A: PARK PLANS, 1981-1989

Protection assists in the development of Park plans and their implementation.

Original arrangement has been retained.

Three folders: Park plans for emergencies, structural fire and wildfire incidents. 1981-1989.

B. SUBSERIES B: INCIDENT REPORTING AND PROCEDURES, 1992-1994

Protection Division is responsible for developing incident management and reporting procedures.

Original arrangement has been retained.

One folder: Paper documents. 1992-1994.

C. SUBSERIES C: AIRSPACE MANAGEMENT, 1984-1996

Protection Division assists in developing plans to address airspace concerns and tracks airspace use. Accretions to this subseries are anticipated as this is a major issue in the Park and additional records have been identified.

Original arrangement has been retained.

One folder: Documents concerning the park relationship with aircraft flying over the park including lists of companies and illustrations of specific aircraft for identification purposes. 1984-1996.

D. SUBSERIES D: HAZARD MANAGEMENT, 1994-1997

Management of the park during hazardous events is also the responsibility of the Protection Division.

Original arrangement has been retained.

Two folders: Documents containing data about and tracking instructions for hurricanes in the Pacific. The subseries also delineates procedures to be followed in the event of a hazardous waste incident. 1994-1997.

II. SERIES II: ERUPTIONS, 1994-2010

The presence of active volcanoes in Hawai'i Volcanoes National Park required a unique set of policies and procedures to be developed within the Protection Division of the Park.

Organized into six subseries: Subseries A, Operations/Plans/Correspondence; Subseries B, Public Information; Subseries C, Hawaiian Volcano Observatory (HVO); Subseries D, Photographs and Maps; Subseries E, Schedules, Rosters and Sign Inventories; Subseries F, Eruption Duty ICS Unit Logs.

173 folders: Records generated by the Protection Division during the course of volcanic eruptions in the park from 1994-2010. Documents include operating plans and procedures, information supplied to the public, interactions with and information supplied by HVO, digital images and maps of eruption sites, scheduling of eruption staff and sign inventories.

A. SUBSERIES A: OPERATIONS/ PLANS/CORRESPONDENCE, 1989-2007

Incident Command System was instituted in the Park in 1989 in response to the continuing eruption of Kīlauea Volcano.

Arranged chronologically.

Sixteen folders: Documenting of eruption plans, eruption operations, Incident Command System structure, correspondence and memoranda. The bulk of the subseries is concerned with documentation of the Mother's Day Lava Flow and resulting Kupukupu wildfire of 2002-2003. 1989-2007.

B. SUBSERIES B: PUBLIC INFORMATION, 1990-2002

Information disseminated to the public about the eruption of Kīlauea was retained beginning in 1990.

Original arrangement was retained.

Nine folders: Briefing statements, press releases, safety messages, visitor comments and interpretation displays. 1990-2002.

C. SUBSERIES C: HAWAIIAN VOLCANO OBSERVATORY (HVO), 1996-1999

The Hawaiian Volcano Observatory holds an internal meeting each week to discuss the most recent events of Kīlauea's current eruption. Notes are taken and disseminated to the Protection Division to keep them apprised of any conditions that may impact staff or visitors.

Arranged chronologically.

Paper documents. 1996-1999.

D. SUBSERIES D: PHOTOGRAPHS AND MAPS, 1997-2002

Photographs of the eruption and maps of eruption lava flows assist in the work of managing eruption sites and visitor access.

Arranged chronologically.

Five folders with photographs and maps of eruption sites. 1997-2002.

E. SUBSERIES E: SCHEDULES, ROSTERS AND SIGN INVENTORIES, 1992-2010

Procedures were developed for tracking the staff assigned to eruption duty and for keeping a record of the signs used at the eruption site and their location.

Arranged chronologically.

Schedules, rosters and notes as well as monthly inventories conducted by the eruption crew of the signs used at the eruption sites. Includes images of the signs. 1992-2010.

F. SUBSERIES F: ERUPTION DUTY ICS UNIT LOGS, 1990-2010

The Incident Command System of the National Park service was implemented to organize and manage the eruption site activities of the Park.

Arranged chronologically.

Logs contain detailed information about staffing at the eruption site and activities at the eruption sites. 1990-2010.
