The current draft of this finding aid was completed in September 2008 and is the result of a backlog cataloging project carried out by the Northeast Museum Services Center (NMSC) during FY 2008.

This document represents materials relating to the E. & G. Brooke Land Company Records at Hopewell Furnace National Historic Site. #### INTRODUCTION

The E. & G. Brooke Land Company was created in 1880 to administer the real estate holdings of the families of Edward and George Brooke, sons of Matthew Brooke, one of the owner's of Hopewell Furnace. *The E. and G. Brooke Land Company Records, 1744-1964* (HOFU 35055) hold administrative and legal documents, correspondence, blueprints, agreements, drafts, petitions and titles. A small group of associated records from the E. & G. Brooke Iron Company are also listed in the finding aid. The records are a significant resource for the park containing documents from the Bishop and Smith Lawsuit and the Potts Claim, lawsuits brought against the owners of Hopewell Furnace (Matthew Brooke, Thomas Brooke and Daniel Buckley) that threatened ownership by disputing land title claims. Additionally, the records provide details about the partition of Hopewell Furnace and the Birdsboro estate after the 1821 death of Matthew Brooke. The records may be used by researchers and park staff to interpret the growth and evolution of Hopewell Furnace as well as the development of the Brooke family iron complex.

In November 2006, 6 archival boxes and nineteen map folders containing the E. & G. Brooke Land Company records and 37 archival document boxes containing the records of the Buckley and Brooke Company and Clingan and Buckley Company Records were brought to NMSC for processing. After the records were moved to NMSC, a survey was conducted. The results of the survey and a review of the park's Collection Management Plan revealed that records from the two manuscript collections had been conflated. Following a processing plan, the two groups of records were separated by provenance. *The Buckley and Brooke Company and Clingan and Buckley Company Records* were processed in FY 2007. *The E. & G. Brooke Land Company Records* were processed in FY 2008 and are described in this finding aid.

Between October 2007 and August 2008, NMSC Museum Specialist, Teri DeYoung, processed and cataloged the collection under the guidance of NMSC Archivist and Backlog Cataloging Program Manager, David Vecchioli. During the project the NMSC was administered by Sara Wolf, Director and Giles Parker, Deputy Director. The project was carried out at the Northeast Museum Services Center with fiscal year 2008 backlog cataloging funds.

The materials were processed according to NPS, NMSC and park standards. Collection processing included flattening the tri-folded documents, removing staples and fasteners and rehousing records in acid-free buffered enclosures. Items larger than the standard 81/2" x 11" were removed from their original file locations for preservation purposes and cross-referenced to their original location with separation sheets. Original envelope folders were photocopied onto acid-free paper and placed inside the new enclosure. The collection catalog record in the Collections Management Module of the Automated National Catalog System Plus (ANCS+) was created and a completion report, *Completion Report: Backlog Cataloging for Hopewell Furnace National Historical Park, E. & G. Brooke Land Company Records, 1744-1964* describes the project methodology and outlines curatorial recommendations (including conservation concerns). This finding aid was written and includes an outline of the series organization and series

descriptions. In August 2008 a draft finding aid was submitted to the park and the collection was returned.

#### **Organization of the Collection**

The records were donated to the park on 1 June 1965 by Robert Manwiller, President of the E. & G. Brooke Land Company. Robert Manwiller succeeded his father Charles who took over the business from the Brooke family during the mid-twentieth century. The accession receiving report (HOFU-431) noted three record volumes and two boxes of deeds. During the present project, the records were found in 6 archival boxes and nineteen map folders. A survey revealed that the documents involving Hopewell Furnace and the Bishop and Smith Lawsuit and the Penn Claim had been separated from the rest of the manuscript collection and arranged chronologically with the oversize materials pulled out and placed in flat files. The remainder of the records was housed in original envelopes: 1-39, 100-108, 110-128 and 200. The envelopes were labeled with a number, title and a listing of the contents. The contents were labeled with the corresponding envelope number. Unlabeled documents were placed in folders titled "unnumbered envelopes." Gaps in the envelope chronology may be resolved through an assessment of the E. & G. Brooke Land Company Records (MG-259) held at the Pennsylvania Museum and Historical Commission. In 1948, the Brooke-Stokes family donated 5 volumes of deeds and receipt books to the park. The park transferred the records to the Commission in 1976 as part of a larger deposit.

In 1985, park staff arranged and conflated the E. & G. Brooke Land Company files with the Buckley and Brooke Company and Clingan and Buckley Company Records. According to a note written to park historian Joseph Lee Boyle on 29 August 1985 concerning the land company records and the Hopewell Furnace owners' records, staff member Karen Guenther wrote "the oversize documents have been placed in drawers...of the map cabinets and arranged in chronological order or alphabetically if undated." She continued "the two boxes of Brooke Co. documents have been arranged...one box is just a chronological run, while the other contains the documents on the two lawsuits. The latter materials probably should be incorporated along with the undated documents grouped by subject." As part of the same project, museum technician Kathy Lang inventoried the contents of the envelopes and noted inconsistencies. A review of a 1992 inventory of the flat files shows that the records were not in chronological or alphabetical order indicated in the above 1985 letter. A card index (HOFU 34130) for the group of records specifies the contents of some envelopes but is incomplete.

During the current project, to the extent possible, discrepancies were resolved and documents that could be identified were moved to the appropriate location. However, the majority of the records were left as it was found. Since, the records associated with Hopewell Furnace were clearly labeled by deed envelope number analogous to the rest of the collection created by the land company, it was decided that the records should be re-associated and cross-referenced to the Buckley and Brooke group of records.

Description: The E. & G. Brooke Land Company Records document the real estate

transactions of the Brooke family from the late eighteenth century to the mid-twentieth century. Founded by George Brooke after the 1878 death of

his brother Edward, the company was a component of an iron

conglomerate started by their father, Matthew Brooke, one of the owners of Hopewell Furnace. The records highlight the company's growth and diversification in iron manufacture and production, mining, real estate and railroading. Notably, the records hold land files and legal documents associated with Hopewell Furnace including the nineteenth-century land title dispute proceedings of the Bishop and Smith Lawsuit and Penn

Claim.

The records hold land files, deeds, titles, mortgages, surveys, maps,

blueprints and correspondence.

#### SERIES DESCRIPTIONS

The E. & G. Brooke Land Company Records, 1744-1964 (bulk dates 1800-1875), are arranged into the following series:

Series I. Land Files

This series holds land records such as titles, mortgages, leases, drafts, surveys, blueprints, agreements, patents, partitions and tax bills. Significantly, the series contains land claim and lawsuits records from the Hopewell Furnace estate associated with the Bishop and Smith Lawsuit, the Penn claim/Potts lawsuit and to a lesser extent, the Mathias Kahler case. The land files are arranged chronologically in numbered envelopes from 1-200 (not inclusive) followed by unnumbered envelopes. Since original order could not be discerned for documents in the unnumbered envelopes, the records retain the order in which they were found. Records previously removed from numbered envelopes and conflated with the Buckley and Brooke Company and Clingan and Buckley Company records were re-associated by provenance. The founding deed for the land company leads the series.

Series II. Associated Companies

#### A. E. & G. Brooke Iron Company

This small assemblage of records holds correspondence, financial documents, furnace drawings, a report on the viability of French Creek Mine and a magazine article about the E. & G. Brooke Iron Company.

Series III. Oversize Materials

These items are grouped together because of their common size. All are intellectually associated with the legal-size materials but are too large to be stored in standard legal-size folders and boxes. Oversize materials are stored in 7 flat boxes, one rolled storage container and 12 map folders.

# **PART 2:**

### CORPORATE HISTORY

#### A Brief History of the E. & G. Brooke Land Company Records

The records of the E. & G. Brooke Land Company provide an overview of the diversity, evolution and history of businesses owned by the Brooke family. A significant part of that history involved Hopewell Furnace and the land title proceedings of the Bishop and Smith Case and the Penn Claim. The records of the lawsuits identified legitimate claim to a good deal of the land owned by Edward and George Brooke. The following corporate history provides a framework for understanding the records held in the manuscript collection. It is not intended to be a comprehensive analysis of a multifaceted conglomerate.

The E. & G. Brooke Land Company was created to administer the extensive real estate holdings of the Brooke family. In 1880, George Brooke reorganized the family's iron conglomerate into three businesses after the 1878 death of his brother Edward Brooke; the E. & G. Brooke Iron Company handled production, the Birdsboro Iron Foundry, established in 1867, continued to focus on manufacturing and the E. & G. Brooke Land Company managed the real estate holdings and transactions associated with the dynamic firm. George and Edward Brooke were sons of Matthew Brooke, one of the owners' of Hopewell Furnace. After Matthew Brooke's death in 1821, the Hopewell and Birdsboro property was partitioned. Matthew Brooke's young children were the benefactors of the Birdsboro complex. Upon their majorities in 1837, Edward and George Brooke assumed responsibility of the business under the firm of E. & G. Brooke. Under the brothers' guidance, the family iron business grew and diversified into a successful organization that became a major economic force in the Birdsboro area.

Edward and George Brookes' connection to the Birdsboro iron works began in 1795 when their grandfather John Louis Barde and two others (John Rene Barde and Paul Henry Mallet Prevost) leased the Birdsboro complex from James Wilson, Mark Bird's son-in-law. The following year, John Louis Barde purchased the compound, a portion of the original Mark Bird estate consisting of 2,213 acres, a forge, grist and saw mill, farm and the former Bird mansion. In 1798, Matthew Brooke purchased an adjacent 1,400 acres of land. In the same year, he and his brother-in-law Daniel Buckley entered into a lease agreement for Birdsboro. In 1800, Matthew Brooke, his brother Thomas Brooke and Daniel Buckley purchased Hopewell Furnace. Initially, Hopewell was managed by Thomas Brooke. He was succeeded by a series of managers and later by his son Clement Brooke, who oversaw and piloted the furnace through its most successful period. Matthew Brooke purchased Birdsboro from the estate of John Louis Barde in

1801.<sup>5</sup> As other Hopewell owners had done before, Matthew Brooke took out his profits from the furnace in the form of pig iron for Birdsboro forge.<sup>6</sup> A review of account books and correspondence for the Birdsboro iron and farm complex indicate the venture was successful despite liturgical trouble and shut downs at Hopewell Furnace due, in part, to land title disputes. The Buckley and Brooke partners faced three long-term costly court cases, the Matthias Kahler case, the Penn Claim (also known as the Potts Lawsuit) and the *Bishop-Smith Case*. In 1801, Matthias Kahler challenged title to 350 acres of Hopewell lands. The judgment to eject Buckley and Brooke was granted in favor of Kahler.<sup>7</sup> The Hopewell owners appealed the verdict and the case languished until 1811 when Kahler was awarded 239 acres.<sup>8</sup> The Penn Claim brought by the owners of Warwick Furnace in 1809 involved 1,000 acres of woodland and concerned "disputed wording of an old grant from the Penns to Reading Furnace on 14 September 1742." The suit was finalized in favor of the defendants in 1815. The longest entanglement was the Bishop-Smith Case. Initiated in 1802 the case was finally adjudicated in 1824. The Pennsylvania Supreme Court case is summarized by Joseph Walker in his book *Hopewell Village: A Social and Economic History of an Iron-Making Community*:

...title given by Benjamin Morris to part of the land was disputed by Matthias Keller (sic) and others. In 1806 Buckley and Brooke brought an action of ejectment against Keller and lost. They then refused to pay the bonds, representing a mortgage on the property, held by John Bishop and John Smith until there should have been an adjustment in the purchase price by Morris. The basis of this action was that Morris had not given valid title to all of the lands. Morris, acting for the executors of Bishop and Smith, brought action against Buckley and Brooke to collect the principal and interest on the bonds. But the Supreme Court upheld the decision of the Berks County court in favor of Buckley and Brooke. <sup>10</sup>

Of the difficulties facing the owners of Hopewell Furnace, Daniel Buckley wrote Matthew Brooke on 6 February 1811 about his anxiety over their liturgical troubles; "my Business ever since I have been concerned in Berks County has been going Backwards and unless something miraculous turns up I fear I shall be Ruined." By 1816, however, the furnace was back in blast and had turned a small profit between 1819 and 1820. In contrast to the troubles facing Hopewell, Birdsboro prospered. During the period that Hopewell was out of blast, 1808-1816,

taxes at Birdsboro increased sharply "indicating a fairly rapid development of the Birdsboro Works." <sup>13</sup>

Shortly after Matthew Brooke purchased Birdsboro, he married John Louis Barde's daughter, Elizabeth. The couple had five children; Anne, Sarah, Edward, George and Elizabeth. Matthew Brooke died unexpectedly of malaria in 1821 when the oldest child, Anne, was 10 and the youngest, Elizabeth, just a year old. At the time of his death, Matthew Brooke was a successful businessman. Besides Birdsboro and a 1/3 share in Hopewell, he held "208 shares of stock in the Farmer's Bank of Reading, 20 shares of stock in the Schuylkill Canal, 8 shares in the Reading and Perkiomen Turnpike, 2 shares in the Center Turnpike Road, and 300 acres of land in Northampton County all amounting to \$13, 982.33 ½." Matthew Brooke's wife Elizabeth and nephews Clement and George Brooke administered the estate. The Hopewell and Birdsboro properties were partitioned and financial settlement was reached in 1824. Samuel Barde, Elizabeth's brother, was given oversight of the Birdsboro iron works and eventually assumed guardianship of the children. 15 Under his guidance, business at the iron works doubled between 1824 and 1827. The estate and assets were turned over to Edward and George Brooke upon their majorities on 1 April 1837. A final division of Hopewell and Birdsboro land occurred in 1847. At one point, a payment of \$17,881 was made by Clement Brooke to the heirs of Matthew Brooke.<sup>17</sup>

Soon after the brothers assumed responsibility, they began a phase of repairs and improvements. In 1844 they built a large grist mill, considered the best in Pennsylvania. In 1846, Hampton Furnace was built along Hay Creek. Designed by George Brooke, the furnace could run using a hot blast method for charcoal or a cold blast method for anthracite coal. By 1848, the E. & G. Brooke firm began to diversify their range of services with the construction of a rolling mill and nail factory. The purchase of French Creek Mine the same year and interest in the Warwick and Joanna mines provided supplies for their growing business. To facilitate the transfer of supplies, the E. & G. Brooke firm invested in the Wilmington and Northern Railroad. The company continued to grow with the erection along the Schuylkill canal of #1 anthracite furnace in 1852. Company holdings were reorganized in 1867 as the Birdsboro Iron Foundry. By the 1870s, Edward and George Brooke owned half the land in Birdsboro and was the primary employer in the area, providing jobs and housing for hundreds of workers. In 1871, #2 anthracite furnace was brought online followed in 1873 by #3 anthracite furnace. In 1872,

Birdsboro was formally recognized as a borough. Edward Brooke was appointed first burgess. As the brother's prospered, the citizens of Birdsboro benefited from their philanthropy. They financed a rectory for St. Michael's Church in 1877 and a remodel of the church in 1885.<sup>21</sup> The family would later donate the Bird Mansion to the Y.M.C.A. and provide ground for the community swimming pool.<sup>22</sup> In 1884 George Brooke donated a lot to the Friendship Fire Company for quarters.<sup>23</sup> In 1900, the water supply system created for the iron company was separated for use by the borough and became the Birdsboro Water Company.<sup>24</sup>

The land company supervised real estate transactions and the construction of commercial and company housing projects, maintaining as many as 250 houses for their iron workers. After the E. & G. Brooke firm was reorganized in 1880, George Brooke retained the presidency of all three companies "with George W. Harrison as treasurer and Richard T. Leaf as secretary." In 1896, D. Owen Brooke, first cousin once removed of Edward and George Brooke, assumed management of the land company. Three years later, Berks County native, Charles Manwiller joined the land company as office manager. However, the corporation remained a family affair. Edward Brooke's son Robert Edward Brooke served as president as did George Brooke's son, Edward Brooke II while his grandsons, George Brooke III and Edward Brooke III, both served as treasurer. George Brooke III retired from the position of treasurer in 1953. Over time, the family liquidated the business and its holdings. Charles Manwiller purchased the firm and a large amount of the associated property. His son, Robert, inherited the business and donated the company's records to Hopewell Furnace National Historic Site in 1965. The firm was dissolved in 1971. Much of the property was sold to Contractor Marvin C. Miller of Maple Springs Development Company.
