Dear Commercial Use Authorization (CUA) Applicant:

You may have a Release of Liability Form, or an Acknowledgement of Risk Form that you ask your customers to sign. Below are the NPS guidelines associated with these types of forms. You must submit your form to the CUA Administrator for review. It's important to note that the CUA holder may not request or require customers to sign a liability waiver form, insurance disclaimer and/or indemnification agreement. For your form to be approved for use it must meet the NPS Commercial Use standards listed below:

Visitor's Acknowledgement of Risk

1. The CUA holder may require guests to sign a Visitor's Acknowledgement of Risks form.
2. The Service-approved sample Visitor's Acknowledgement of Risks form is provided as an Attachment to this letter.
3. The CUA holder will submit to the Park for approval its proposed Visitor's Acknowledgement of Risks form, if any
4. Provide the NPS at least 30 days in advance of any proposed changes in the form.
5. If no Visitor's Acknowledgement of Risks form will be used, the CUA holder will advise the park of this intention within their application package.
6. The CUA holder *may not* request or require guests participating in activities to sign a liability waiver form, insurance disclaimer and/or indemnification agreement.

VISITOR'S ACKNOWLEDGEMENT OF RISKS

In consideration of the services of _____ their officers, agents, employees, and stockholders, and all other persons or entities associated with those businesses (hereafter collectively referred to as "_____") I agree as follows:

Certain risks are inherent in each activity and cannot be eliminated without destroying the unique character of the activity. These inherent risks are some of the same elements that contribute to the unique character of this activity and can be the cause of loss or damage to my equipment, or accidental injury, illness, or in extreme cases, permanent trauma or death. _____ does not want to frighten me or reduce my enthusiasm for this activity, but believes it is important for me to know in advance what to expect and to be informed of the inherent risks. The following describes some, but not all, of those risks.

I acknowledge that engaging in this activity may require a degree of skill and knowledge different from other activities and that I have responsibilities as a participant. I acknowledge that the staff of _____ has been available to more fully explain to me the nature and physical demands of this activity and the inherent risks, hazards, and dangers associated with this activity.

I certify that I am fully capable of participating in this activity. Therefore, I assume and accept full responsibility for myself, including all minor children in my care, custody, and control, for bodily injury, death, or loss of personal property and expenses as a result of those inherent risks and dangers identified herein and those inherent risks and dangers not specifically identified, and as a result of my negligence in participating in this activity. I have carefully read, clearly understood, and accepted the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon me, my heirs, assigns, personal representative, and estate and for all members of my family, including minor children.
