



Lake Mead National Recreation Area Fee Schedule - 2013

Entrance fees are for entrance into Lake Mead National Recreation Area. Current locations are East Lake Mead Parkway, East Lake Mead Blvd., Boulder Beach, Katherine Landing, Cottonwood Cove and Temple Bar. Additional locations will be added in future projects. Holders of annual passes will be authorized to enter the park through the far right-hand lane of the entrance station.

Lake Use Fee for Vehicles and Motorcycles

In order for the pass to be valid it must be affixed directly to the vehicle on the lower left (driver's) side of the windshield. The sticker will not be honored if placed elsewhere or if it is not directly affixed to the vehicle.

Lake Use Fee for Vessels

All motorized vessels entering the park will be assessed a lake use fee charge. This includes vessels that are in dry storage and/or maintained in slips at the marinas.

In order for the pass to be valid it must be affixed directly to the vessel on the port (left) bow next to, but not overlapping the state registration. The sticker will not be honored if placed elsewhere or if it is not directly affixed to the vessel.

Senior Federal Lands Passes and Access Federal Lands Passes

These passes are non-transferable and are valid at federal entrance fee areas. The holders receive a 50% discount on user fees, such as campground and lake use fees as applicable. The passes admit permittee and accompanying passengers in a single, private, non-commercial vehicle. **The Senior Federal Lands Pass and Access Federal Lands Passes** do not cover tours.

Senior, Access, and Annual Federal Lands Passes

These passes are honored in Federal Recreation Areas that are administered by these agencies: Bureau of Land Management, U.S. Fish & Wildlife Service, Bureau of Reclamation, Army Corps of Engineers, National Park Service and U.S. Forest Service.

Federal Interagency Passes

cover admission to all Federal Areas with entrance fees for 12 consecutive months beginning with the month issued. They are non-transferable and valid for entrance fees only. They do not cover tours. The owner of the pass must be present for the pass to be used.

America the Beautiful-National Parks/ Federal Recreational Lands Pass

Active duty military members and their dependents qualify for a free America the Beautiful-National Parks and Federal Recreational Lands Pass. Present your valid Common Access Card (CAC) or military dependent ID (DoD form 1173) for your free yearly pass.

Senior Federal Lands Pass	lifetime	\$10 per person (seniors 62 and older)
Access Federal Lands Pass	lifetime	Free - medically determined to be permanently disabled
Federal Interagency Pass		\$80 valid for one year from month purchased
