PREFACE

This document, *Finding Aid for the Fox-Brockway letters* (18610 – 1630), describes a group of letters written to Mary Brockway, of Sutton Vermont, by George Fox, and his sister Diana, of Lowell, Massachusetts. They were donated by descendents of the Brockway family, Annette Gibavic and Charlotte Rafferty, both of Massachusetts. They were cataloged at the Lowell National Historical Park by Clee A. Ace, volunteer, with the help of Dan Walsh, Museum Specialist.

This finding aid has a table chronologically listing all the letters in the collection as donated to the park. The original letters are held in the Cultural Resources collections in the Curatorial Department of Lowell National Historical Park. Photocopies of all original documents were created and are maintained in both the Library and the Curatorial Departments of the park.

Researchers are requested to contact the park Librarian for assistance in accessing and using this material. INTRODUCTION

This finding aid describes materials in the Fox-Brockway Letters. 1861 - 1863. It is a group of 27 letters which have been photocopied. The collection was processed in chronological order.

Mary Brockway had been a mill worker in Lowell, Mass., but returned to Sutton, Vermont, at about the time of the outbreak of the Civil War. In Lowell, she boarded at Boott Cotton Mills boarding house #45, kept by Amanda Fox, where she met Amanda's son George. The letters from George Fox to Mary Brockway were initially written from Lowell. Later, after he joined the 6th Massachusetts Volunteer Regiment, he wrote from Virginia.

George and his cousin David Goodhue joined the regiment and were sent to Virginia together. George's letter of August 29, 1862, gives Mary his military address. His next letter on September 21, 1862, describes the journey from the Lowell camp to Virginia. They were both wounded in battle and captured in early June, 1863. David was sent to a Richmond hospital and George was taken to the Confederate, Jerusalem Hospital, Southampton County, under the direction of head surgeon, Dr. White. On the 30th of June, 1863, David died in the Richmond hospital, after having a leg amputated. Then Doctor White wrote to the Fox family notifying them that George had died at the Jerusalem hospital on the 18th of June, 1863. He noted that "...he was decently coffined and buried." George's sister Diana wrote to Mary on September 4th, 1863 to tell her of George and David's deaths.

Description: The Fox-Brockway letters were written to Mary Brockway of Sutton,

Vermont by George Fox of Lowell, Mass. They cover the period June 9, 1861 to September 4, 1863. They reflect his personal feelings and views, as well as containing information about people they both knew. After George joined the 6th Massachusetts Volunteer Regiment during the Civil War, his letters continue from Virginia and describe the events of the war that George encounters. The last letter, from his sister, describes his death.

This collection of letters was donated to the Lowell National Historical Park by two sisters, Annette Gibavic and Charlotte Rafferty, descendants of Mary Brockway. The letters were stored at Annette Gibavic's home in

Leverett, MA.
