## Educational Fee Waiver Application

The National Park Service grants fee waivers to school groups or other bona fide educational institutions. To obtain a waiver certain criteria must be met to include:

1. Is this school group recognized by a federal, state, or local government as a bona fide educational or scientific institution?  
If yes, please provide documentation from that government body stating your group's official recognition (accreditation certificate or letter from a government body attesting to the legitimacy of the school). **Note:** A school that has been granted an educational tax exemption by the Internal Revenue Service or similar state tax authority will qualify for a fee waiver, please include exemption.
2. The school group is required to provide a statement as to the educational purpose of the visit. The visit must relate to the resources of either Montezuma Castle or Tuzigoot National Monuments. A general statement to the effect that the visit is for "educational purposes" is insufficient by itself.
