

**Permit Guidelines for GPS- Based Activities**  
**New River Gorge National River**  
**Gauley River National Recreation Area**  
**Bluestone Scenic River**

1. New River Gorge National River, Gauley River National Recreation Area and Bluestone National Scenic River encourage GPS- based activities that involve virtual caches within the park in accordance with guidelines established by [www.earthcache.org](http://www.earthcache.org). Virtual caches posted on Earthcache will not be subject to the same permitting process required of physical caches as long as the activity occurs in areas where visitors can normally go and does not involve the development of new social trails. Park reserves the right to require a Special Use Permit for GPS- based activities involving virtual caches to avoid undesirable resource and visitor impacts if they become apparent.
2. GPS- based activities involving placement of physical caches require a Special Use Permit to be applied for and approved prior to placement in the park, and each physical cache will require a separate permit with a maximum of two permits per individual/organization. If approved, the permit will be valid for 12 months, from March 1 through February 28, and may be reauthorized for a second twelve- month term provided all terms of the original permit have been met. After the issuance of a permit for two consecutive twelve- month periods, there will be a waiting period of twelve months before permittee can reapply for another GPS- based activity permit involving a physical cache.
3. To obtain a Special Use Permit for GPS- based activities involving a physical cache, requester will complete an Application for Special Use Permit (link to GPS- based activity specific permit application) and provide the park with the following information for the proposed cache location: a 7.5 minute quadrangle map showing the location of the requested cache site; GPS coordinates for the cache site, utilizing base map datum NAD- 27 or WGS- 84); a description of the cache container; educational content of cache; photos of cache location; photo of cache container to be used; and an explanation of why the requested site would benefit from a physical cache. The park has the right to assign general desired locations for physical caches and to review educational content for accuracy.
4. At this time, no park fees or cost recovery charges associated with obtaining a permit will be imposed as the cache content must meet the parks' criteria for providing an appropriate educational message that complements the park's mission and is relative to the park location of the cache. Permittee will not impose a fee or charge for individuals to participate in the search and visit of caches in the park.
5. Permittee will be responsible for the content of the cache, quarterly inspections of the cache, soundness of the container, and upkeep of web information regarding the cache site. Park reserves right to randomly inspect cache and remove materials that are not in compliance with the permit conditions (repeated violation of cache content will result in revocation of permit and immediate removal of cache).
6. Permittee will not change location of cache during term of permit without prior written approval from park.
7. Park has right to revoke any permit if determination is made the cache creates safety concerns, damages or jeopardizes the integrity of park resources, gives rise to user conflict issues or adversely impacts park operations. If park determines authorized cache is creating undesirable resource and visitor impacts and relocation of cache is deemed necessary, park will either remove cache or the existing permit can be amended to reflect new park- approved location.

8. Failure to comply with park guidelines will result in revocation of issued GPS- based activity permits and could prevent the issuance of any future GPS- based activity permits to the non- compliant group or individual.
9. If permit for authorized cache is revoked or not reauthorized, cache will be removed from park property within five days and cache publication will be immediately removed from all website(s). Unauthorized GPS- based activity physical caches will be removed and treated as abandoned property, and the responsible person may be cited. Failure to obtain the required permit or permit violations could result in fines up to \$5,000.00 and/or six months in jail.
10. Initially, there will be no more than ten permitted GPS- based activity physical caches within the park at any one time. Dependent upon yearly reviews of cumulative program impacts, the park may determine to permit additional physical caches, reduce the number of permitted physical caches, or maintain the current maximum of ten permitted physical caches.

### GPS- based Activity Posting Guidelines

1. Permittee will include the following statement on all GPS- based activity website(s) where a park cache is listed: *"The fundamental purpose of the National Park Service (NPS) is to 'conserve the scenery and the natural and historic objects and the wild life therein and to provide for the enjoyment of the same in such manner and by such means as will leave them unimpaired for the enjoyment of future generations. (16 U.S.C. 1)'. Placing a cache on NPS lands without a permit is a violation of NPS regulations. These regulations are intended to protect the fragile environment and the natural, cultural and historical resources found in parks. You are ultimately responsible for the cache, so please make sure you know and understand the rules."*
2. Permittee will provide the park with addresses of all websites on which the cache will be posted. Permittee will post the park permit requirements and cache searching guidelines on all website(s) containing online descriptions of authorized cache locations.
3. Permittee will accurately rate difficulty of finding cache and the inherent dangers of backcountry travel and navigation when caches are located in remote and/or rugged areas of the park. Permittee will communicate any known hazards to searchers and any equipment needed for search.

### Cache Content

1. Content of cache will be of educational or interpretive value and will be related to the location of the cache i.e. a cache located near Thurmond would contain educational material relating to Thurmond.
2. Contents of each cache will be approved by the park prior to its placement to ensure it complements the park's education mission. Inappropriate or misleading information will be rejected and permit application will be denied.
3. Prohibited for placement in cache are: tobacco, ammunition, weapons, drugs (medications), alcohol, food, items with vulgar or pornographic content, personal/hygiene products, chemicals or scented/perfumed items/substances, explosives/fireworks, and advertising materials.
4. The National Park Service permit sticker (provided by the park) must be adhered to the lid of the cache container in such a manner that it is visible through the lid. The park regulations for searching/visiting caches must be located inside the lid (sticker provided by the park) so that an individual who opens the cache will be able to read the regulations. See attached photos for example.

## Cache Placement

1. Cache locations will be pre- approved by the park.
2. Cache placement shall involve no digging or disturbing of rocks, soil or vegetation.
3. Cache placement in areas of high visitor use (Kaymoor, Fern Creek, Nuttallburg, Beauty Mountain, Fayette Station, Cunard, Thurmond, Grandview, Stone Cliff, etc) is restricted to established trails and other areas designated for public access.
4. Locations that could lead to the creation of new "social" trails will not be approved. Cache sites in remote areas of the park need to be located in previously disturbed areas that are able to withstand additional use, such as mine benches and logging roads.
5. Cache sites that require searchers to illegally cross railway lines are prohibited.
6. Cache sites along the river must be placed above the high water line and outside the floodplain.
7. Caches shall not be buried or placed in locations that are dangerous or unsafe to access such as on cliffs, in trees, within mine portals, underground, underwater or within park structures.
8. Cache placement is prohibited in any area that could have an adverse impact upon any endangered, threatened, or species of concern or could have an adverse impact upon any natural, historical or cultural resources.
9. Park hours and closures will be observed during placement of cache.
10. Maximum cache container size is 1.5 liters and should not be readily discernable by the general public. Containers must be clear, non- breakable and waterproof with some form of latch or lid that seals to prevent content exposure to moisture. Permit identifier (permit sticker provided by the park) will be attached to the lid and be visible through the container lid and contain park approved guidelines for searching/visiting caches.
11. Cache shall not be placed in park areas being considered for prescribed burns.
12. Clues for locating cache must be appropriate and family/kid friendly.

## Guidelines for Searching for and Visiting GPS- Based Activity Physical Caches

1. No digging or disturbing of rocks, soil or vegetation.  
  
Prohibited for placement in cache are: tobacco, ammunition, weapons, drugs (medications), alcohol, food, items with vulgar or pornographic content, personal/hygiene products, chemicals or scented/perfumed items/substances, explosives/fireworks, and advertising materials.
2. Park hours and closures will be observed during cache searches.
3. Metal detectors may not be utilized in cache searches.
4. GPS- based activities are subject to all park rules and regulations. It is your responsibility to know the park rules and regulations.







# Bank of Glen Jean

The **Bank of Glen Jean** is located in the unincorporated community of Glen Jean, West Virginia. The bank was the financial center of a railroading, mining and financial conglomerate belonging to William McKell, son of Thomas G. and Jean McKell, the town's namesake. Built in 1909, the bank operated until 1939. It is now a visitor contact center for New River Gorge National River.<sup>[2][3]</sup>

The bank is built in stone masonry, using local sandstone found above the Sewell coal seam. Exterior walls are 28 inches thick. The floors and roof are of steel construction. A panel above the door reads "BNank 1909." A 1917 addition constructed for McKell's coal and railroad operations uses wood floors and roof. The sign above its entrance states "McKell."<sup>[3]</sup> The bank resembles a smaller version of the 1907 Fayette County National Bank in Fayetteville.<sup>[4]</sup>





Describe the present and original (if known) physical appearance

Historical photographs of the Bank of Glen Jean from the beginning of the 20th century indicates that the original building appearance has survived since it was constructed in 1909. The inscription of its construction date appears over the main entrance to the bank. An addition was built on to the original structure by William McKell in 1917 on the rear portion of the bank fronting the main street of Glen Jean.

The 1909 bank, and its 1917 addition, were constructed of stone in the style or pattern of random broken ashlar with raised beaded joints. The stone is of lower guyandot sandstone quarried in the immediate Glen Jean area. The guyandot sandstone is the strata of rock exposed above the Sewell seam of coal, which was the richest seam in Fayette County and areas surrounding Glen Jean. The foundation stone was hand cut and also quarried locally. The large hand hewn stone that constitutes the plinth or water table, average four feet in length and were apparently quarried and cut on the site.

The exterior walls of the bank are uniformly 28 inches thick. The thirteen windows on the front of the original bank building and the ones in the 1917 addition are double hung and are two lights with a transom over each. Stone lintels constitute the inside facings of all windows.

The front of the building was cut on 45 degree corners with the unusual angle of the front archway main door being also in 45 degree angles facing main street. Cheek walls surround the archway entrance. A keystone supports the main door archway and the handcut marker-stone that bears the simple description of the structure, "Bank 1909". The intrados in the arch are regular, the extrados being irregular and being tied to the random ashlar pattern. The roof can be characterized as a top over roof. The overhang is galvanized iron with string course cornice.

The interior floors of the bank are ceramic mosaic tile, 1" trimmed hexagon shaped along the outside edges in the lobby and front office.  $\frac{1}{2}$ " black and white ceramic mosaic tile with a 10" marble base accompanies the tile in the same area. The 12 foot ceilings are plaster on masonry with 42" oak wainscoating bordering the walls in the lobby.

The vaults in the bank are largely intact. Access to five vaults is gained through an ornate double door opening on a walk through vault.

The structural system in the 1909 section is of steel; in the 1917 section, wood.

The construction of the bank and its addition is an example of the type of construction popular at the turn of the century with Italian stone masons who were originally lured to Fayette County for railroad bridge construction and the retaining walls necessitated by the steep slopes of the New River Gorge and the hollows the railroads traversed.

The interior of the building deteriorated greatly from the bank's closing in the 1930's until acquired by the present owners. Remodeling in the upstairs of the bank for offices has not harmed the integrity or appearance of the building. The structure is sound, there being no evidence of settling or structural deterioration. Sited on approximately one-half acre itself and surrounded by six acres the present owners have acquired, the Bank of Glen Jean is an architectural reminder of the "glory days" of Glen Jean.

### Statement of Significance (in one paragraph)

The Bank of Glen Jean, at Glen Jean, Fayette County, West Virginia is significant as the most prominent work of architecture in its community and for its association with William McKell, one of the most outstanding of that group of now legendary men, the West Virginia "coal barons".

### Explanatory Notes

1. The small community of Glen Jean, nestled in the rugged hills of the southern West Virginia coal fields, was founded in the early 1870's. Beginning in the late 1880's and continuing until the advent of the Great Depression, Glen Jean prospered as a "boom town", being the heart and center of the McKell coal "empire". Constructed during the midst of this "boom", the Bank of Glen Jean became the symbol of Glen Jean's prosperity and, with its massive stone facade, was easily the most architecturally imposing building in the town. As the "boom" years faded and Glen Jean settled back into a rather sleepy village in the mountain country of Fayette County, the imposing structure of the Bank of Glen Jean has taken on even greater significance as the one remaining symbol of a past era of prosperity and as the foremost architectural landmark of the community.

2. The Bank of Glen Jean was constructed in 1909 to serve as the center of the financial empire of William McKell, opening its doors on August 11, 1909. As that empire grew, so did the bank; a large addition, architecturally compatible with the main 1909 unit, was erected in 1917 and bears the name "McKell" in a lintel over the door.

At the time of his construction of the Bank of Glen Jean in 1909, William McKell (1871-1939) was one of West Virginia's most prosperous coal magnates. In addition to owning the entirety of Glen Jean, McKell owned vast amounts of land, coal properties, and railroads.

Glen Jean had become the center of the great McKell financial empire in the late 1880's with the arrival of Thomas G. McKell, who had acquired a 12,000-acre tract in 1873 at what was then White Oaks, Fayette County. The elder McKell continued to acquire lands and coal mines for over a decade before finally moving to Fayette County. He changed the name of the little village to Glen Jean (in honor of his wife) and quickly proceeded to build a sizable town that included an opera house, hotels, and department stores and played a major role in the development of the nearby town of Thurmond as well. His only son William took



up residence at Glen Jean in 1893 and upon Thomas McKell's death in 1904 became the owner of the vast McKell enterprises, including the newly formed (1900) McKell Coal and Coke Company.

William McKell was an individual about whom, due to his unusual, or eccentric, behavior, many stories abound. Controlling much of Fayette County political life, he was strictly paternalistic toward his workers. He won the first successful legal suit ever brought against the United Mine Workers Union for damages due to a strike. He personally organized sporting events among his workers and even invented a new variation of baseball, called "letemhitit", that became wide-spread in the southern coal fields. Upon his death in 1939, McKell left a fortune of 13 million dollars. It would have been more except that when the Bank of Glen Jean closed on January 10, 1939, McKell paid all the depositors from his own assets. At the time the bank closed McKell, near death, was still the bank president. C.P. Calloway was vice president and Charles Wilburn served as the last cashier. A bachelor, McKell's financial concerns were scattered at his death, much of the Glen Jean property passing to the New River Company.

The Bank of Glen Jean is the single remaining structure that is representative of a once flourishing West Virginia financial domain, and this Fayette County community's most outstanding architectural landmark.


