Additional Documentation, May 2014

The Main Street Banking Historic District was listed in the National Register of Historic Places in April 2005. Since that time, the resource count included with the original nomination has been found to be slightly inaccurate. An updated resource count has been prepared for Section 5. One contributing resource, located at 828 E. Main Street, has been demolished and is *not* included in the count of contributing resources.

Additionally, the addresses in the inventory of contributing resources included in Section 7 of the nomination have been discovered to be incomplete. An updated inventory using the current address (or address range) for each property is provided below. Finally, the 6 properties within the historic district that were individually listed prior to the historic district nomination have been identified in the inventory, along with the year of their NRHP individual listing.


