CONTRIBUTING PROPERTY

ADDRESS: 1702 W Flower Phoenix AZ 85015

This property was listed as a non-contributor in the 1/24/07 National Register Nomination.

The property owner has requested that the State Historic Preservation Office review the house for historic integrity. The property was listed as a non-contributor because of the 2 story addition on the property. After research and consulting with the City of Phoenix, the addition is completely separate from the house and the house does still convey integrity. The City agrees with the recommendation that this house is a contributor to the North Encanto Historic District.

INTEGRITY

The Arizona State Historic Preservation Officer requests that the Keeper of the National Register of Historic Places classify the property at 1702 W Flower Phoenix AZ to reflect its contributing status to the North Encanto Historic District, as it does, in fact, not contribute to the historic fabric of the District.
