Additional Documentation, May 2014

The Main Street Banking Historic District was listed in the National Register of Historic Places in April 2005. A nomination update and boundary increase was prepared for the district in 2013. Since that time, the addresses in the inventory of contributing resources included in Section 7 of the nomination have been discovered to be incomplete. An updated inventory using the current address (or address range) for each property is provided below. The boundary increase area has a total of four contributing resources and one non-contributing resource. The resource at 705-711 Main Street/26 S. 8th Street has multiple addresses but is a single building. Locations of all contributing and non-contributing resources are shown on the attached sketch map entitled "Main Street Banking Historic District, 2013 Boundary Increase."


