We request that the **Alford Park Warehouse** (NRIS # 02001665), located in Kenosha, Kenosha County, Wisconsin, and listed in the National Register on December 31, 2002, be removed from the National Register of Historic Places. The warehouse was significantly damaged by fire in December 2011 and demolished early in 2013. The attached article details the removal of the warehouse.

At the meeting of the Wisconsin Historic Preservation Review Board on November 22 2013, the property was removed from the Wisconsin State Register of Historic Places.
