ADDRESS OF THE PROPERTY:

The address of the Mickles Bridge was 0.25 miles north of AR 10 and approximately 1 mile west of Yell County Road 49 in the Mickles vicinity, Yell County, Arkansas. It is now located just to the west of City Hall on East 8th Street (AR 10) in Danville, Yell County.

DATE AND CAUSE OF DELISTING:

The Mickles Bridge was moved from the Mickles vicinity to Danville, Yell County, Arkansas, in 2013. However, approval for the move was not obtained from the National Park Service in accordance with the regulations at 36 CFR § 60.14(b). As a result, in accordance with 36 CFR § 60.14(b)(4), the bridge should be delisted.

CONFIRMATION OF RELOCATION:

The move of the Mickles Bridge was confirmed on November 13, 2013, through a site visit by the AHPP.

APPROVAL OF THE ADDITIONAL DOCUMENTATION BY THE STATE REVIEW BOARD:

The delisting of the Mickles Bridge from the National Register of Historic Places was approved by the State Review Board on April 2, 2014.
