

The Culvahouse House was listed on the National Register on July 6, 1982. The house was listed for its local significance in architecture and architecture/engineering under the requirements of the Meigs County Multiple Resource Nomination. The Culvahouse House was lost due to a fire in 2009. As a result of the loss due to fire, the property has lost the significance for which it was listed and no longer retains integrity of setting, design, materials, workmanship and feeling. Therefore, the Culvahouse House should be removed from the National Register.
