Finding Aid

Description:

Subsequent to World War Two and the Korean War, the National Park Service found itself greatly in need of new construction due the decay incurred during the war years and the ever-increasing number of tourists. The Service lacked a systematic method and enough on-site rangers to communicate the message of the importance of preserving America's natural and cultural treasures. In 1955, the Director of the Park Service, Conrad Wirth, envisioned a plan to improve conditions at the Parks by developing modern conveniences and implementing a system-wide method of educating the visiting public. This new plan, called "Mission 66", introduced the concept of the "Visitor's Center", now a common sight in all National Parks and Monuments. Park planners, architects and landscape architects devised the concept to incorporate visitor facilities, interpretative programs and administrative offices in one structure. In contrast to the rustic style buildings constructed during the Civilian Conservation Corps, these new buildings embraced contemporary structural form. Contrasting with the reserved character of the CCC style, these Mission 66 buildings conveyed a bold commercial appearance that enticed and attracted visitors. Modern materials and designs characterized the new architecture, with open interior spaces and expansive areas to provide views of nearby natural and cultural resources. Instantly recognizable, these buildings advertised public service, orientation information and other amenities. This program represented the largest undertaking ever initiated by the National Park Service. By the end of the billion dollar program in 1966, the parks and the public enjoyed a wealth of modern services, including 584 new comfort stations, 220 administrative buildings, 36 service buildings, over 1,300 housing units and more than 100 new visitors centers. Additionally, the National Park Service acquired 78 new parks and monuments. This forward-looking program achieved the infrastructure and staffing so that the broadest number of visitors could enjoy America's natural and cultural treasures, while simultaneously providing the greatest amount of protection to preserve these treasures.
